ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B2-3, Neighborhood Mixed-Use District symbols as shown on Map No. 1-G in the area bounded by:

West Superior Street; North Racine Avenue; the East-West public alley next Southwest of West Superior Street; the North-South public alley next West of and parallel to North Racine Avenue.

SECTION 2. This Ordinance takes effect after its passage and due publication.

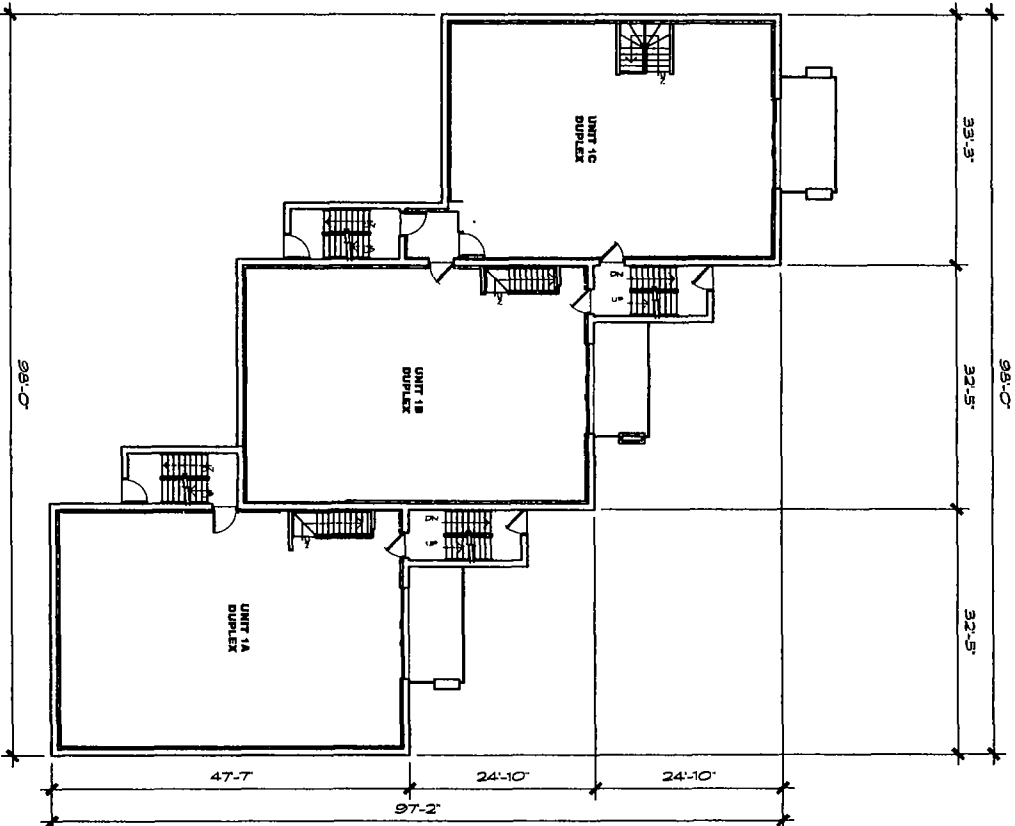

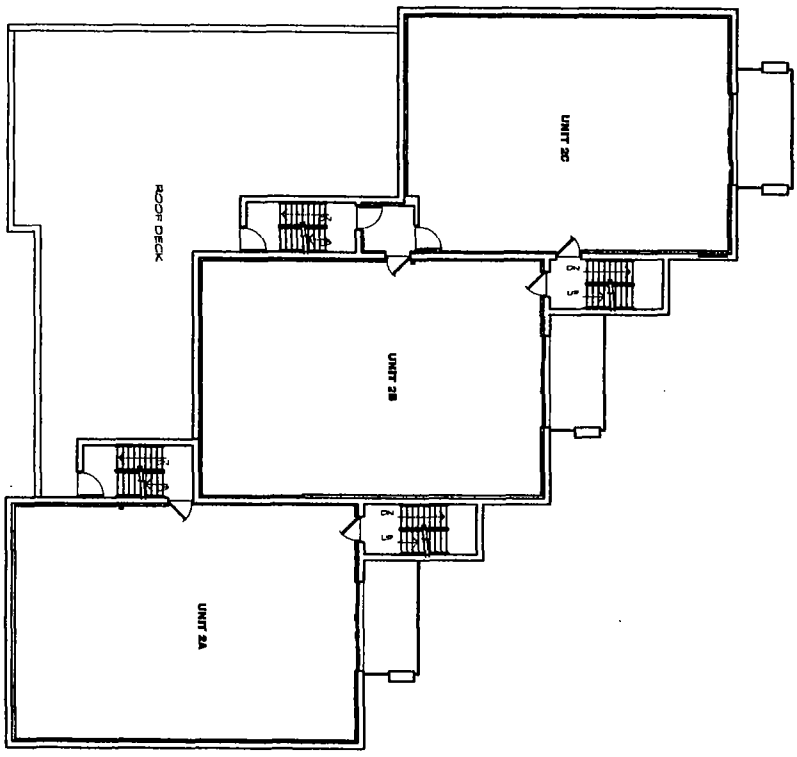

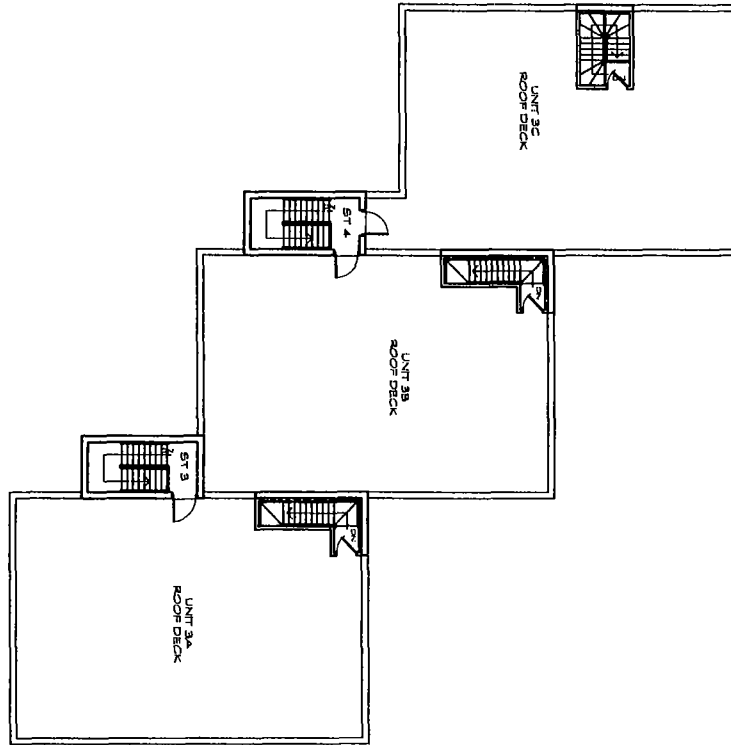

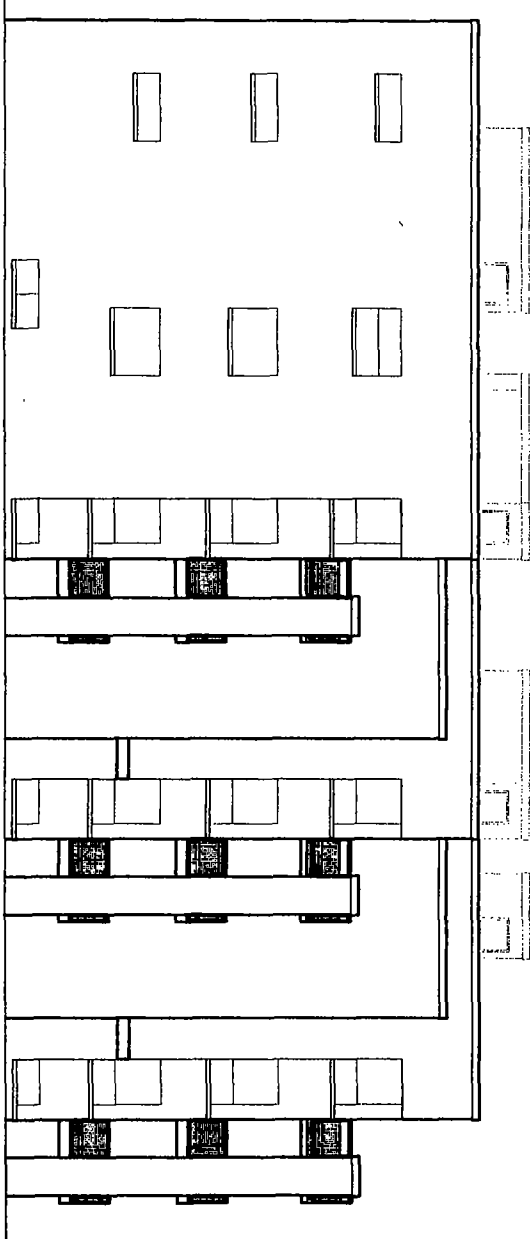
