## Typical 12 Unit Building - 2 Bedrooms (Each) Building 1 & 8

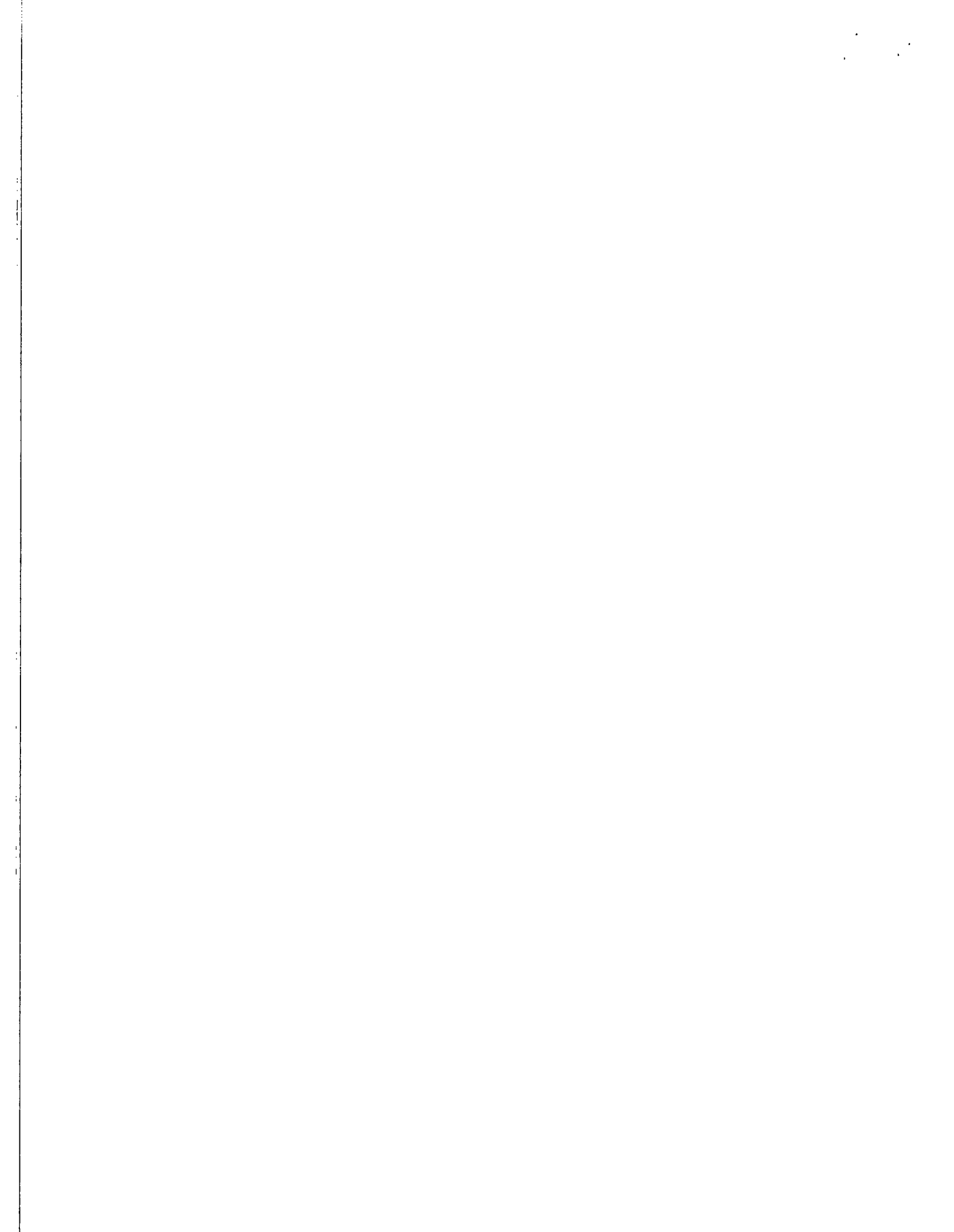


2nd, 3rd, & 4th Floor Plan

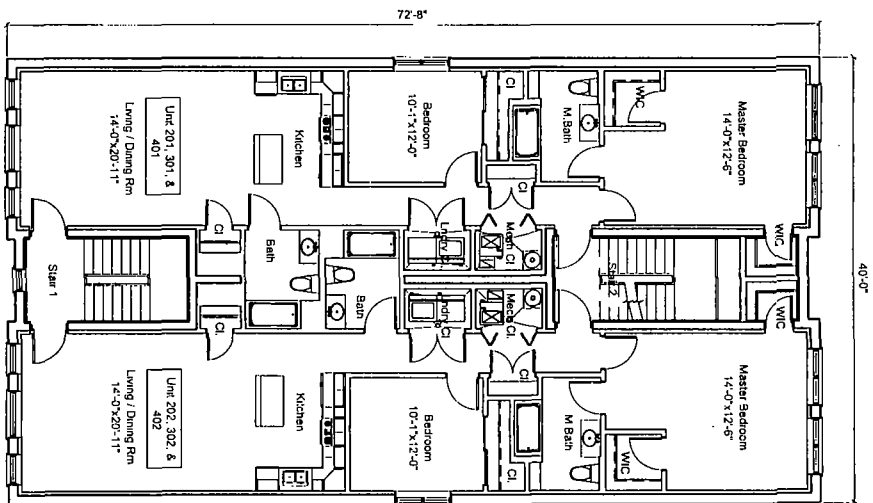


Typical 8 Unit Building - 2 Bedrooms (Each)

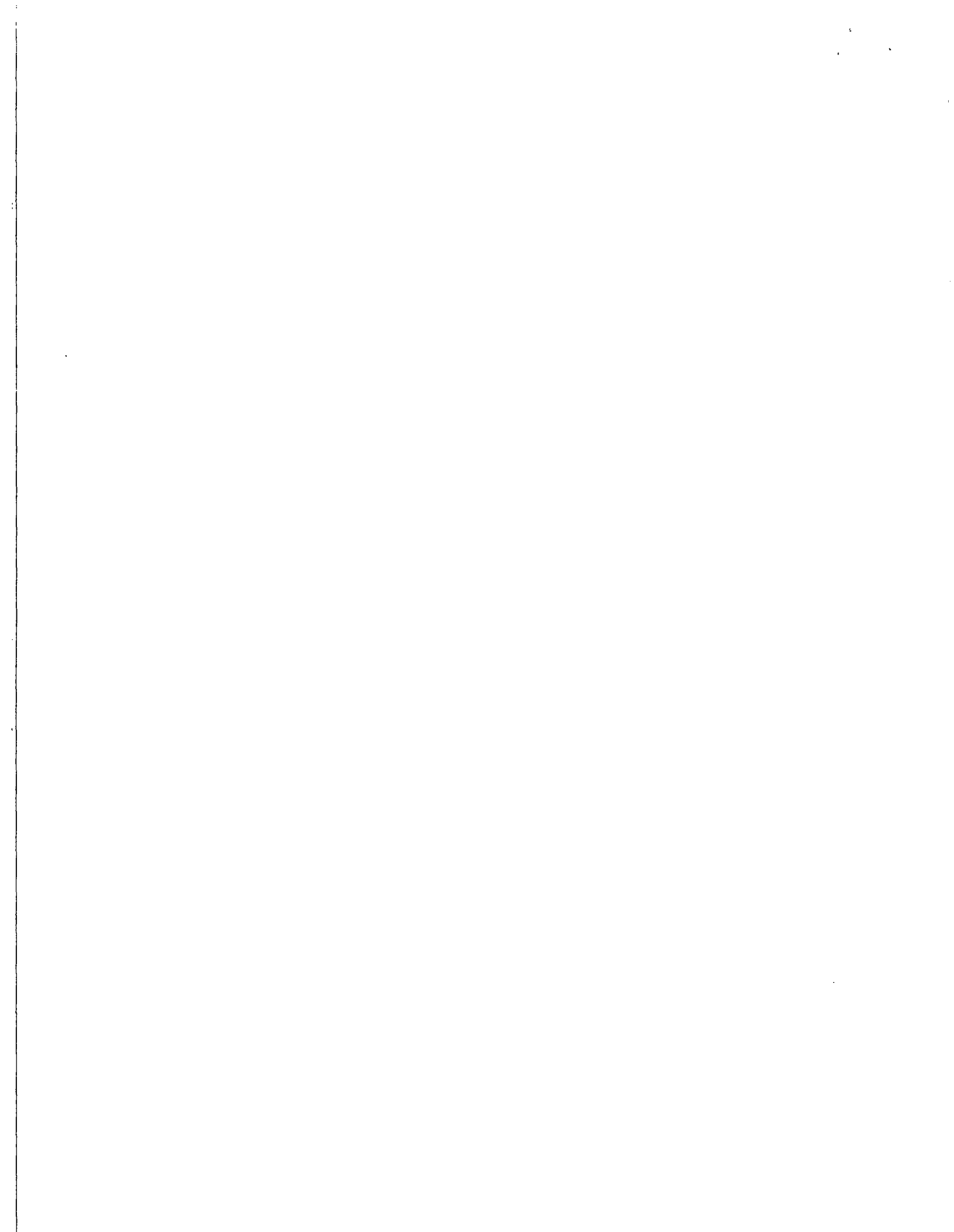


Typical 8 Unit Building - 3 Bedrooms (Each)
