NORTHWESTERN MEMORIAL HOSPITAL

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to NORTHWESTERN MEMORIAL HOSPITAL, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use three (3) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 259 E. Erie St..

Said Canopy(s) at E. Erie measure(s):

One (1) at one hundred eighty point four one (180.41) feet in length, and two point eight three (2.83) feet in width for a total of five hundred ten point five six (510.56) square feet.

Said Canopy(s) at E. Ontario measure(s):

One (1) at one hundred seventy-two point zero eight (172.08) feet in length, and one point five (1.5) foot in width for a total of two hundred fifty-eight point one two (258.12) square feet.

Said Canopy(s) at E. Erie measure(s):

One (1) at fifty-two point six six (52.66) feet in length, and thirteen point five eight (13.58) feet in width for a total of seven hundred fifteen point one two (715.12) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1101587 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

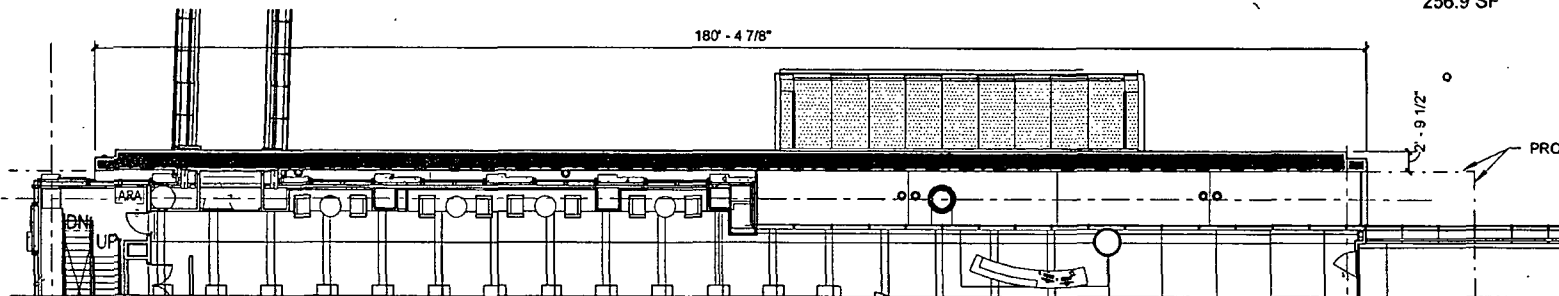

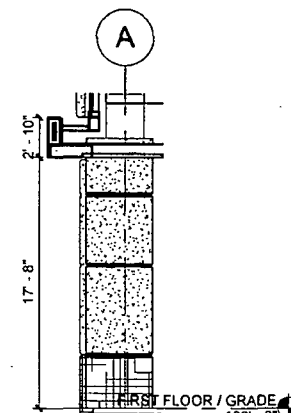
