BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the C2-2 Motor Vehicle Related Commercial District symbols and indications as shown on Map No. 7-I in the area bounded by

N. Willetts Court; a line 178.75 feet northwest of the intersection of N. Sacramento Avenue and N. Willetts Court as measured along the southwest line of N. Willetts Court; the alley next southwest of N. Willetts Court; and a line 278.75 feet northwest of the intersection of N. Sacramento Avenue and N. Willetts Court as measured along the southwest line of N. Willetts Court.

to those of a B2-3 Neighborhood Mixed-Use District.

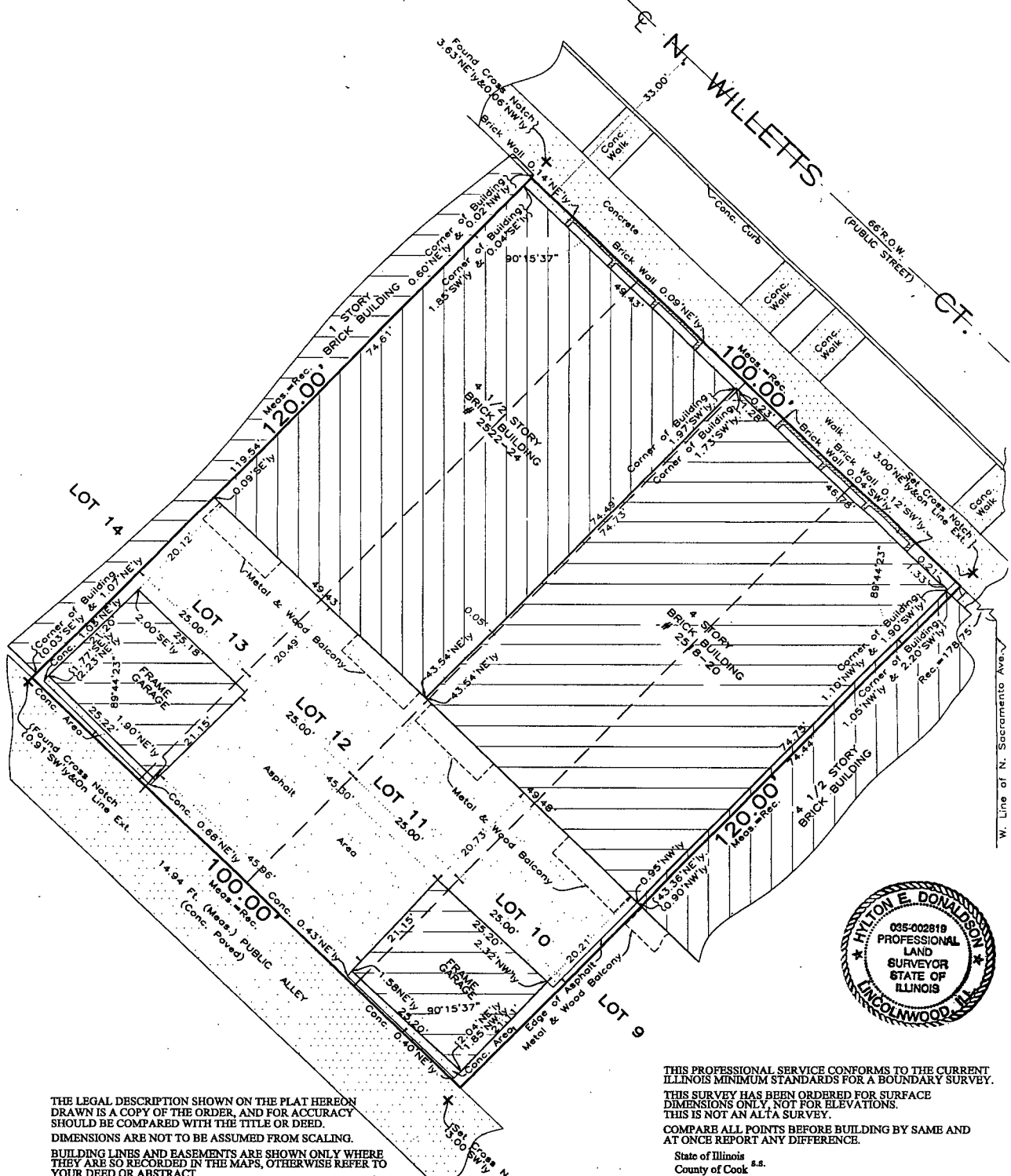
