ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map Number 9-G in the area bounded by:

A line 50.0 feet north of West Eddy Street; the public alley next east of and parallel to North Racine Avenue; a line 25.0 feet north of West Eddy Street; and North Racine Avenue

to those of an RM-4.5 Residential Multi-Unit District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about December 15, 2021, the undersigned will file an application for a change in zoning from RT-4 Residential Two-Flat, Townhouse and Multi-Unit District to RM-4.5 Residential Multi-Unit District on behalf of the applicant, Gregory Davey and Sara Whaley Davey, for the property located at 3537 N.
