KINGSBURY STREET CAFE

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to KINGSBURY STREET CAFE, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Exhaust Fan projecting over the public right-of-way adjacent to its premises known as 1523 N. Kingsbury St..

Said Exhaust Fan at Public Alley measure(s):

One (1) at one (1) foot in length, and one point five eight (1.58) foot in width for a total of one point five eight (1.58) square feet. Existing exhaust fan is approximately twelve (12) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1129635 herein granted the sum of four hundred (\$400.00) per annum in advance

A 25% penalty will be added for payments received after due date.

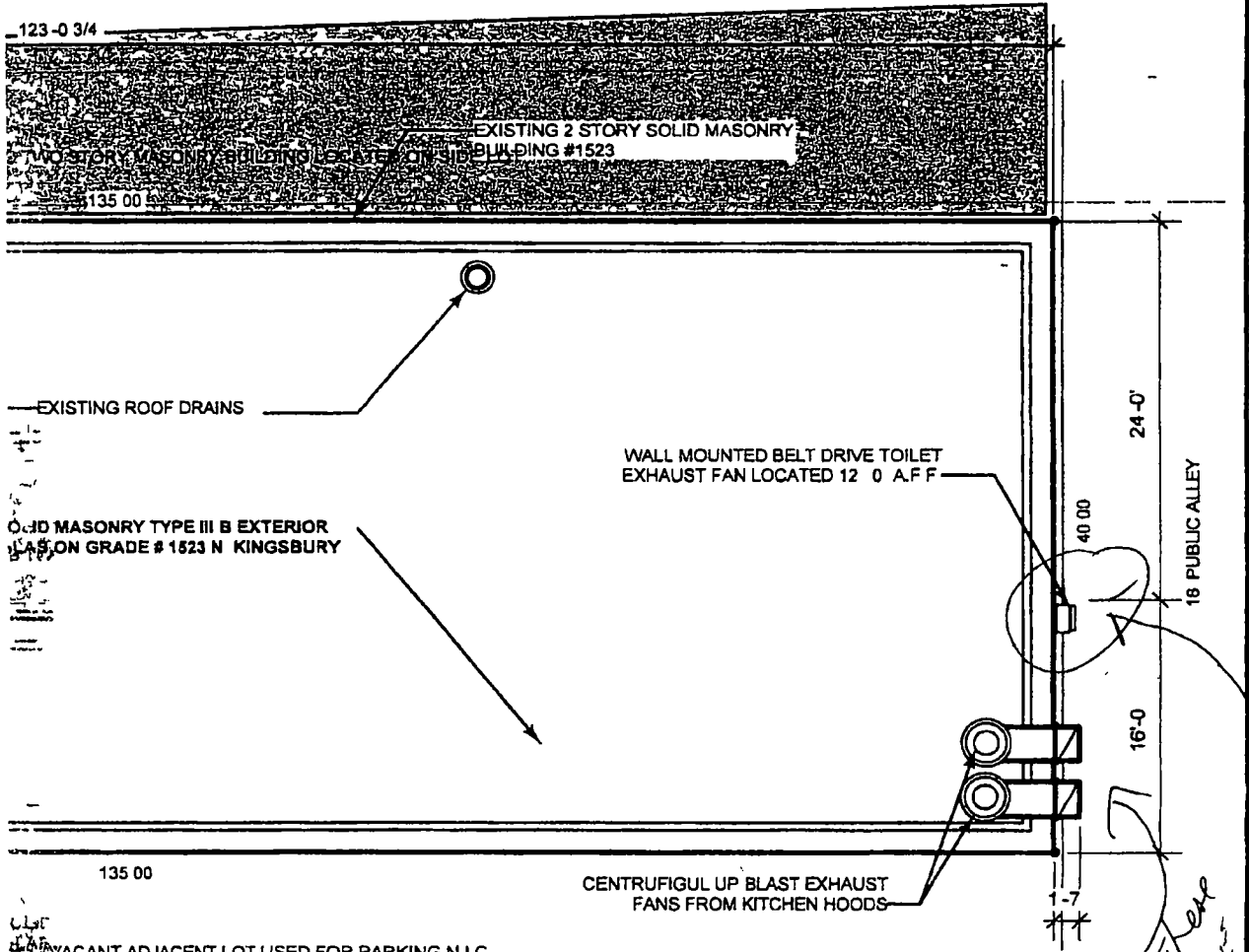

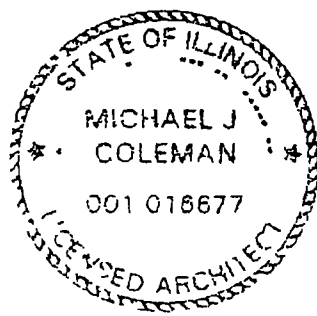
