BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No.11-H in the area bounded by

the alley next north of and parallel to West Irving Park Road;
a line 125 feet east of and parallel to North Oakley Avenue;
West Irving Park Road; and a line 100 feet east of and parallel
to North Oakley Avenue,

to those of a B1-3 Neighborhood Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

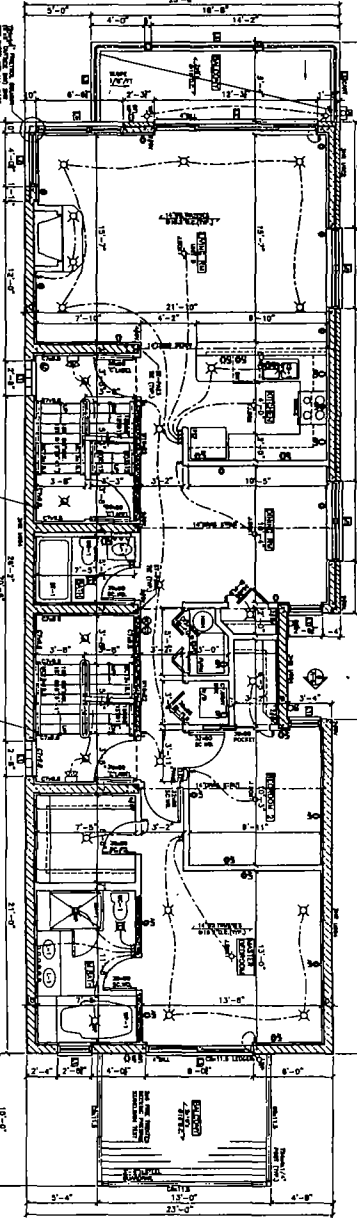
FIRST FLOOR PLAN



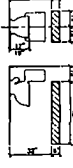
SECOND FLOOR PLAN



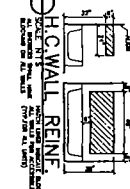

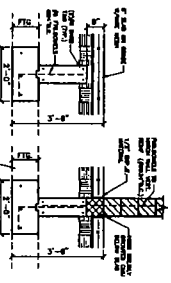
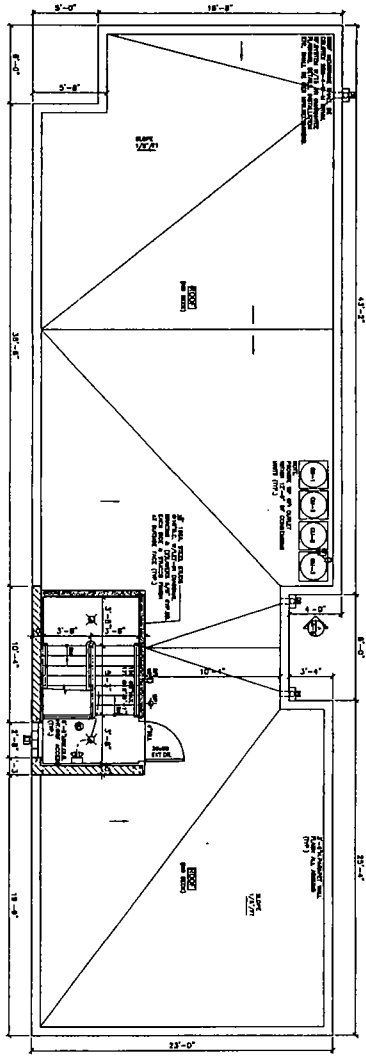
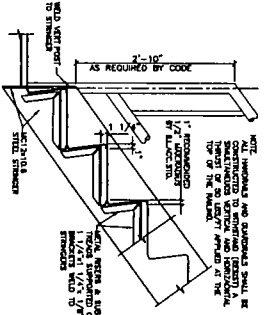


FIG-UNDER SHEAR WALLS

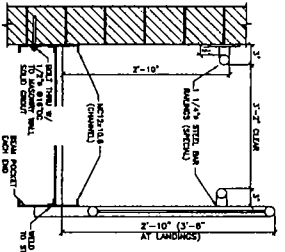
ROOF DECK PLAN

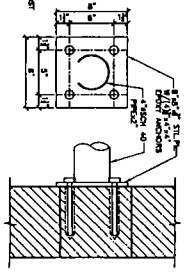
EXTERIOR STAIR DETAIL

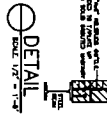


HANDRAIL DETAIL
