ORDINANCE

WHEREAS, the City of Chicago (the "City"), is a home rule unit of government under Article VII, Section 6(a) of the Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

~~WHEREAS, the Board of Education of the City of Chicago (the "Board"), is a body corporate and politic, organized under and existing pursuant to Article 34 of the School Code of the State of Illinois, 105 ILCS 5/1-1, et seq. (the "School Code"); and~~

WHEREAS, the Board is the beneficial owner of the real estate located at 6529-33 South Stewart Avenue and 6530 South Harvard Avenue, Chicago, Illinois, which is improved with the former Hayes Administration Building (the "Building"), and is legally described on Exhibit A attached hereto (the "Property"); and

WHEREAS, title to the Property is held by the City, as Trustee, in Trust for the Use of Schools; and

WHEREAS, pursuant to Section 34-21(b) of the School Code, by a vote of no less than two-thirds (2/3) of its full membership, the Board determined that the Property has become unnecessary for school purposes, and that the sale of the Property is in the best interests of the Board; and

WHEREAS, one appraisal was made for the Property indicating the appraised disposition value of the Property, as follows:

Appraiser: KMD Valuation Group, LLC

Disposition Value as of March 1, 2017: \$75,000 to \$100,000; and

WHEREAS, the Board advertised the Property for sale and received one bid for the Property, which was opened in the Board's Department of Procurement and Contracts on March 13, 2017, the bid closing date; and

WHEREAS, such bid was submitted by Greater Southwest Development Corporation ("GSDC"), an Illinois not-for-profit corporation, in the amount of Thirty Thousand and No/100 Dollars (\$30,000); and

WHEREAS, GSDC subsequently increased its bid to the amount of Seventy-Five Thousand and No/100 Dollars (\$75,000; the "Increased Bid" or "Purchase Price"); and

WHEREAS, GSDC has proposed to repurpose and redevelop the Building for residential housing; and

WHEREAS, on September 27, 2017 the Board, pursuant to Resolution Number 17-0927-OP2 (the "Resolution"), voted by more than two-thirds (2/3) of its membership to accept GSDC's Increased Bid in the amount of the Purchase Price for the Property; and

WHEREAS, the Resolution includes a request to the City to convey the Property to GSDC in accordance with Section 34-21(d)(1) of the School Code subject to the use restriction that the Property may not be use as a K-12 charter school and that the grantee must obtain a

Certificate of Occupancy from the City of Chicago for the Building within three (3) years from the date of the deed; now, therefore,

Be It Ordained by the City Council of the City of Chicago:

Section 1. The foregoing recitals are hereby adopted as the findings of the City Council.

Section 2. The City hereby accepts GSDC's Increased Bid to purchase the Property, provided that the dollar amount that GSDC pays to the Board for the Property equals the Purchase Price.

Section 3. The Mayor or his proxy is authorized to execute and the City Clerk or the Deputy City Clerk is authorized to attest a quitclaim deed conveying to GSDC all right, title and interest of the City, as Trustee, in Trust for the Use of Schools, in and to the Property subject to the following use restrictions:

The Property may not be used as a K-12 charter school. Grantee must obtain a Certificate of Occupancy from the City of Chicago for the Building within three (3) years from the date of the deed. Title to the Property will revert back to the City of Chicago, in Trust for Use of Schools, as legal title holder of record for the benefit of the Board if these use restrictions are breached without the prior written approval of the Board's Chief Operating Officer.

Section 4. The interest of the City, as Trustee, in Trust for the Use of Schools, in and to the Property shall be conveyed in its "as is-where is" condition, and the deed conveying such interest shall provide that the City and the Board are to be released and discharged from any and all responsibility or liability with respect to the Property's physical, structural and environmental condition.

Section 5. The Mayor, the City Clerk, and the Commissioner of the Department of Fleet and Facility Management (the "Commissioner"), or a designee of the Commissioner, are each authorized to execute and deliver on behalf of the City such supporting documents and certificates and to do such other things consistent with the terms of this Ordinance as such officers and employees shall deem necessary or appropriate in order to implement the provisions of this Ordinance.

Section 6. If any provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

Section 7. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 8. This Ordinance shall take effect upon its passage and approval.

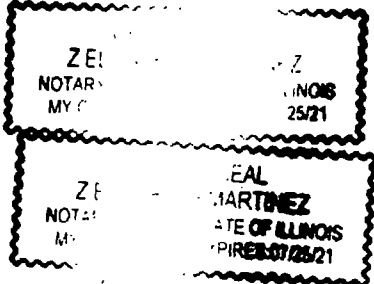
