Prohibition Of Parking During Specified Hours.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 080 of the Municipal Code of Chicago, the operator of a vehicle shall not park such vehicle upon the following public way in the areas indicated during the hours specified:

N. Stockton Drive (east side) from a point 1045 feet north of W. La Salle Drive to a point 230 feet north thereof – Parking prohibited during specified hours, 5:00 A.M. to 1:00 P.M., Wednesdays and Saturdays, May 15 to November 1, except vendor trucks with permits on N. Stockton Drive

N. Stockton Drive (east side) from a point 720 feet north of W. La Salle Drive to a point 115 feet north thereof – Parking prohibited during specified hours, 5:00 A.M. to 1:00 P.M., Wednesdays and Saturdays, May 15 to November 1, except vendor trucks with permits on N. Stockton Drive

N. Stockton Drive (west side) from a point 1195 feet north of W. La Salle Drive to a point 145 feet north thereof – Parking prohibited during specified hours, 5:00 A.M. to 1:00 P.M., Wednesdays and Saturdays, May 15 to November 1, except vendor trucks with permits on N. Stockton Drive

N. Stockton Drive (east side) from a point 1485 feet north of W. Fullerton Parkway to a point 40 feet north thereof – tow away zone (accessible symbol)

N. Stockton Drive (east side) from a point 565 feet south of W. Dickens Drive to a point 50 feet south thereof – tow away zone (accessible symbol)

N. Stockton Drive (east side) from a point 1580 feet north of W. La Salle Drive to a point 50 feet north thereof – tow away zone (accessible symbol)

N. Stockton Drive (east side) from a point 835 feet north of W. La Salle Drive to a point 100 feet north thereof – tow away zone (accessible symbol)

N. Stockton Drive (west side) from a point 1350 feet north of W. La Salle Drive to a point 40 feet north thereof – no parking tow away zone

SECTION 2. This ordinance shall take effect and be in force upon its passage and publication.
