To those of a B3-5, Community Shopping District

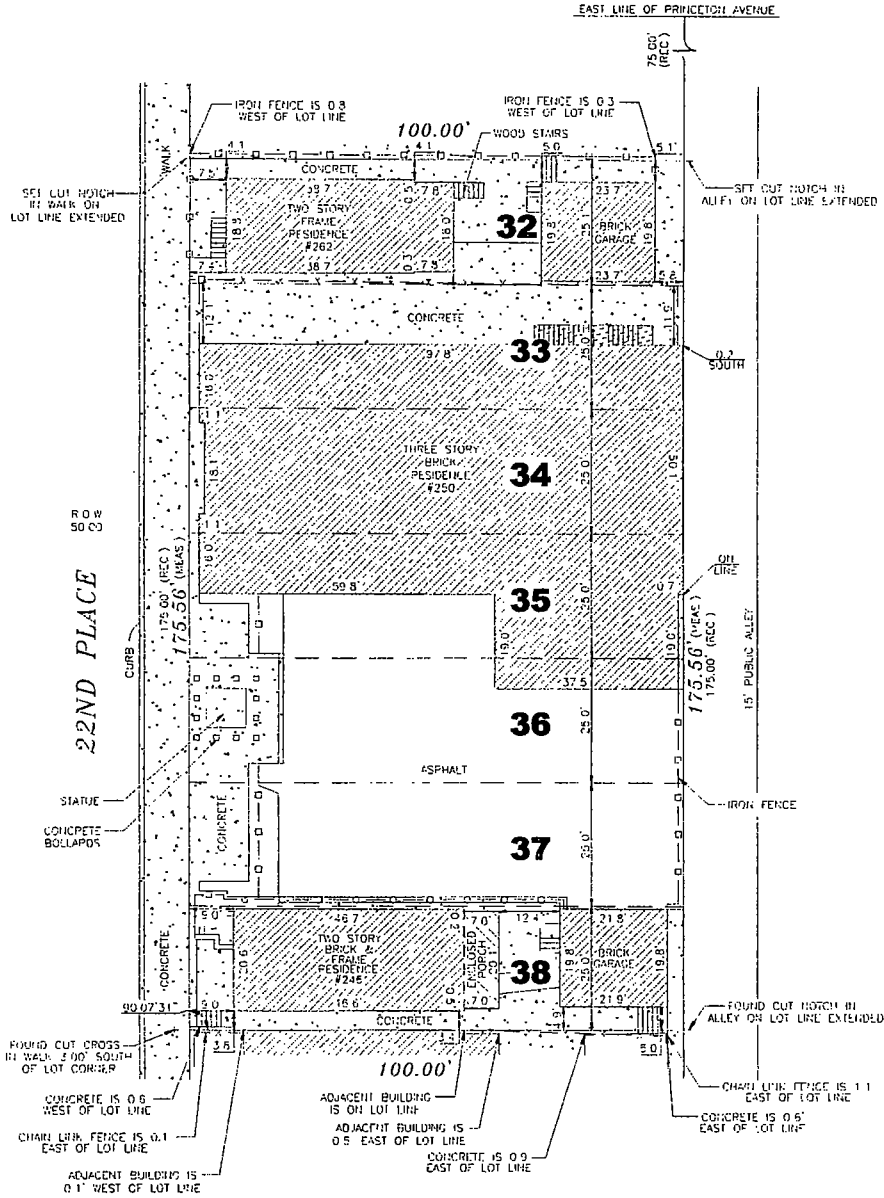
