ORDINANCE 401 E ONTARIO CONDO ASSOCIATION Acct. No. 295190 - 1 Permit No. 1094400 ---

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 401 E ONTARIO CONDO ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, eight (8) Decorative Fence(s) on the public right-of-way adjacent to its premises known as 401 E. Ontario St.

Said Decorative Fence(s) at E. Ontario Street measure(s): One (1) at twenty-two point zero eight (22.08) feet in length, and ten (10) feet in width for a total of two hundred twenty point eight (220.8) square feet.

Said Decorative Fence(s) at E. Ontario Street measure(s): One (1) at seventeen (17) feet in length, and ten (10) feet in width for a total of one hundred seventy (170) square feet.

Said Decorative Fence(s) at E. Ontario Street measure(s): One (1) at fifteen point nine two (15.92) feet in length, and ten (10) feet in width for a total of one hundred fifty-nine point two (159.2) square feet.

Said Decorative Fence(s) at E. Ontariio Street measure(s): One (1) at twenty-two point five (22.5) feet in length, and ten (10) feet in width for a total of two hundred twenty-five (225) square feet.

Said Decorative Fence(s) at E. Ontario Street measure(s): One (1) at twenty-two point five eight (22.58) feet in length, and ten (10) feet in width for a total of two hundred twenty-five point eight (225.8) square feet.

Said Decorative Fence(s) at E. Ontario Street measure(s): One (1) at sixteen point nine two (16.92) feet in length, and ten (10) feet in width for a total of one hundred sixty-nine point two (169.2) square feet.

Said Decorative Fence(s) at E. Ontario Street measure(s): One (1) at seventeen (17) feet in length, and ten (10) feet in width for a total of one hundred seventy (170) square feet.

Said Decorative Fence(s) at E. Ontario Street measure(s): One (1) at twenty-two (22) feet in length, and ten (10) feet in width for a total of two hundred twenty (220) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of **B**usiness Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1094400 herein granted the sum of three thousand (\$3,000.00) per annum in advance.


A 25% penalty will be added for payments received after due date.
