ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-1, Limited Manufacturing/Business Park District and RM-5, Residential Multi-Unit District symbols and indications as shown on Map No. 1-I in an area bound by

West Warren Boulevard; a line 208.0 feet west of and parallel to North Western Avenue; the public alley next south of and parallel to West Warren Boulevard; And a line 258.0 feet west of and parallel to North Western Avenue

to those of a RM-5, Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.

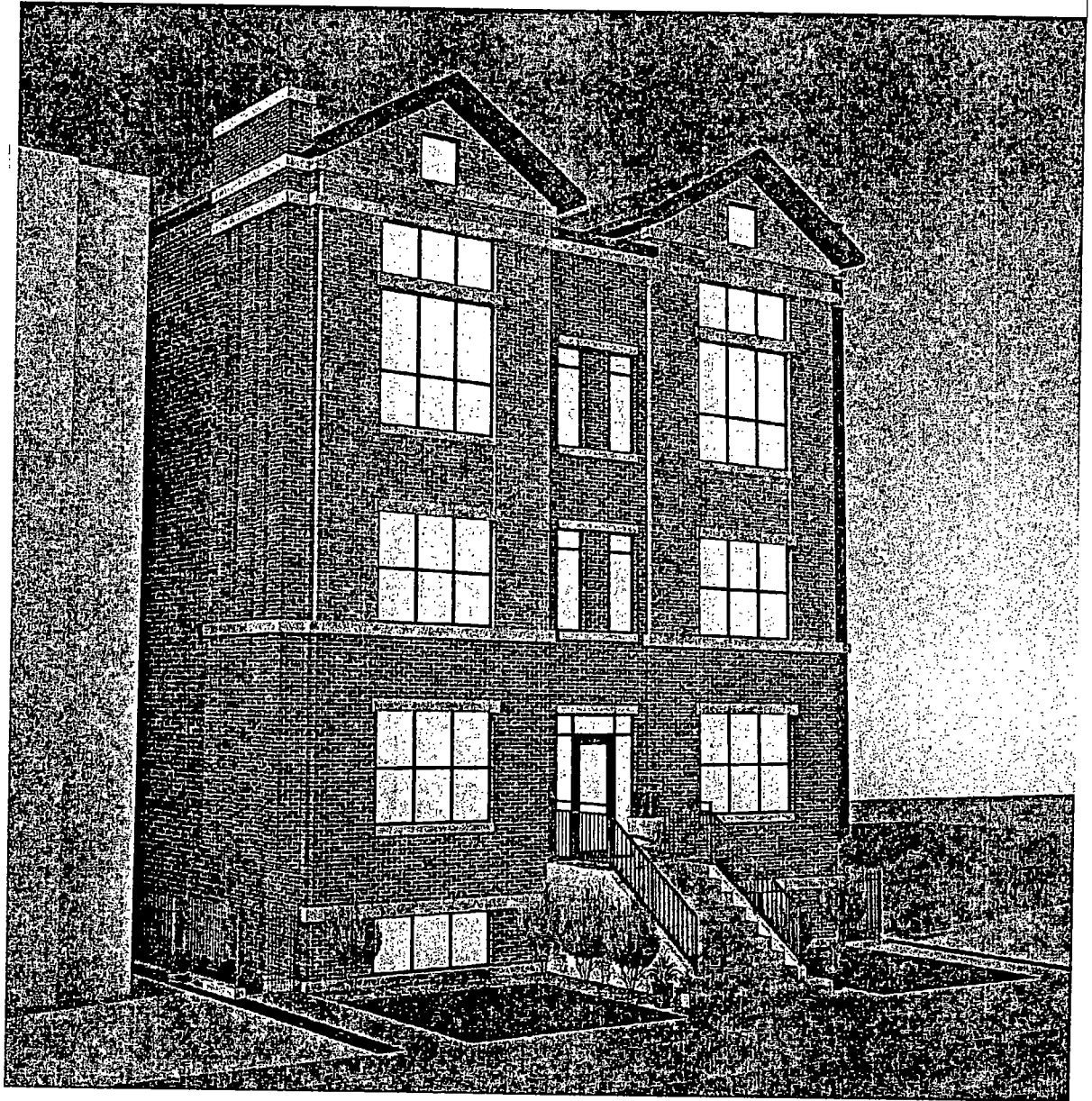

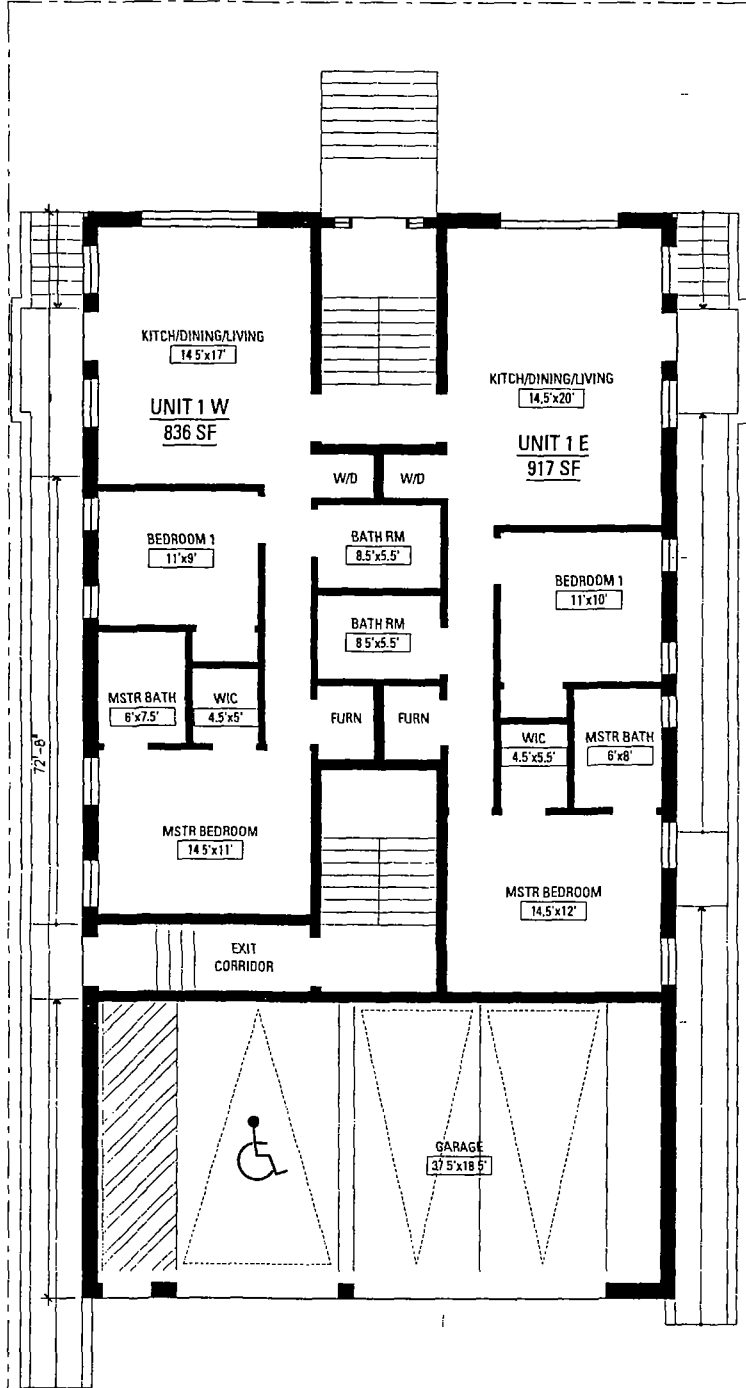
SITE PLAN

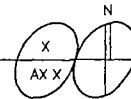
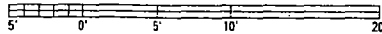

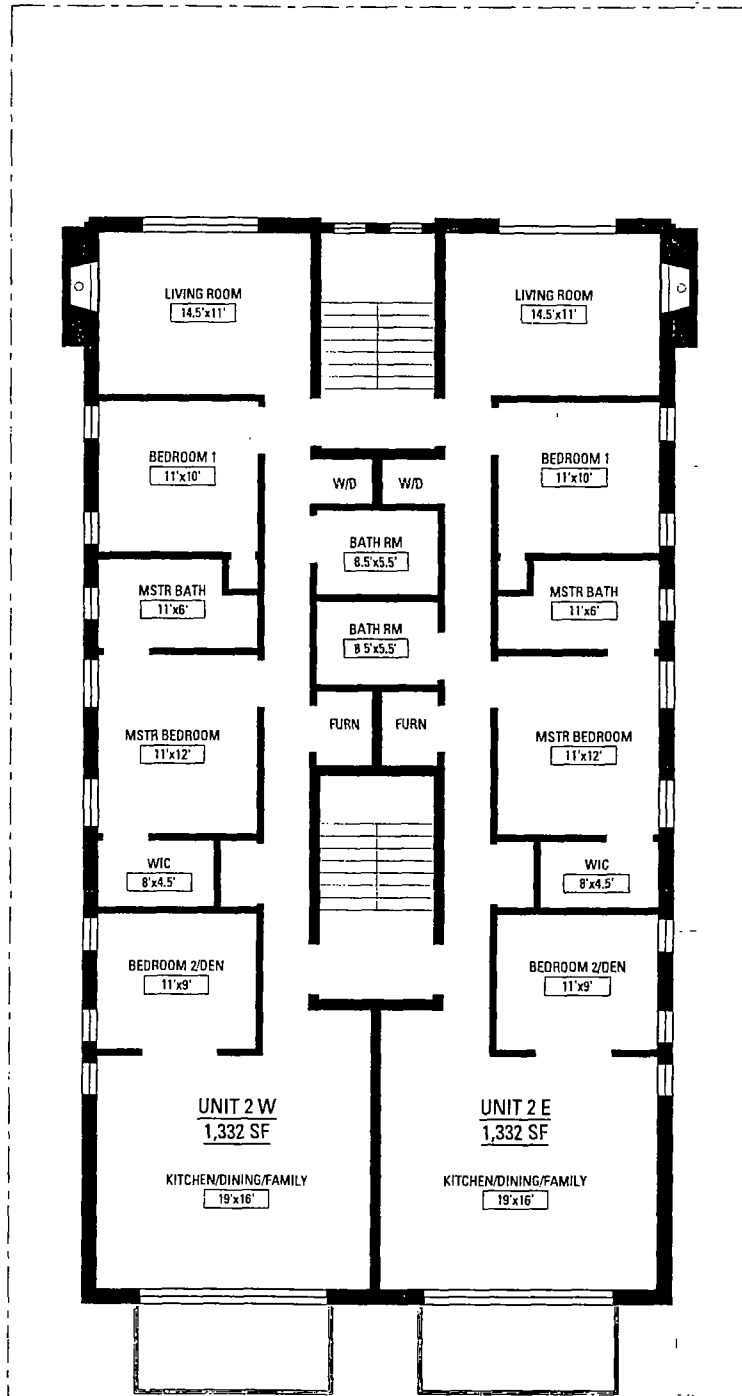
TYP. BSMT & FIRST FLOOR PLANS
