BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 3-F in the area bound by

a line 100 feet south of and parallel to West Hobbie Street; North Larrabee Street; a line 150 feet south of and parallel to West Hobbie Street; and the alley next west of North Larrabee Street

to those of a B2-5 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

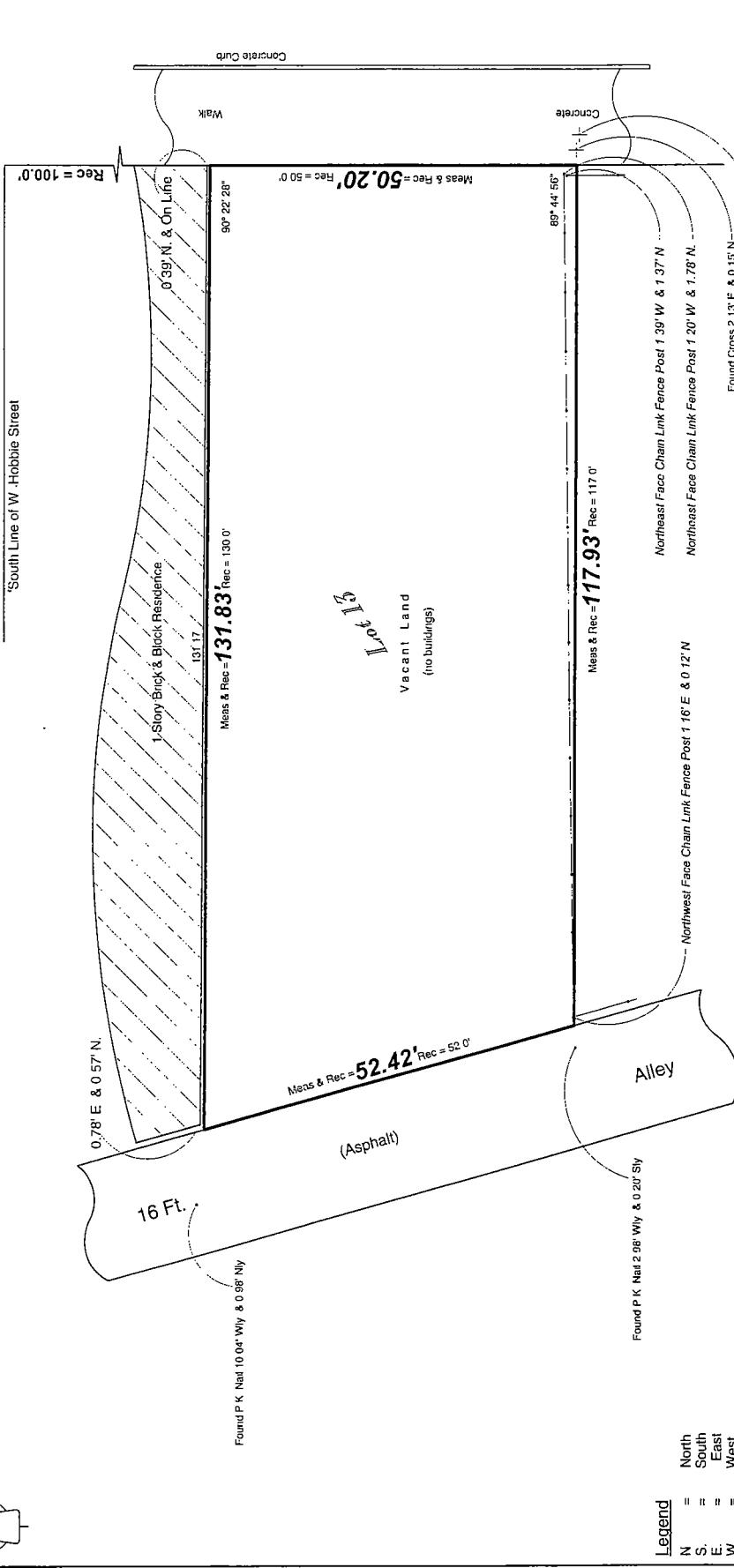

SITE PLAN

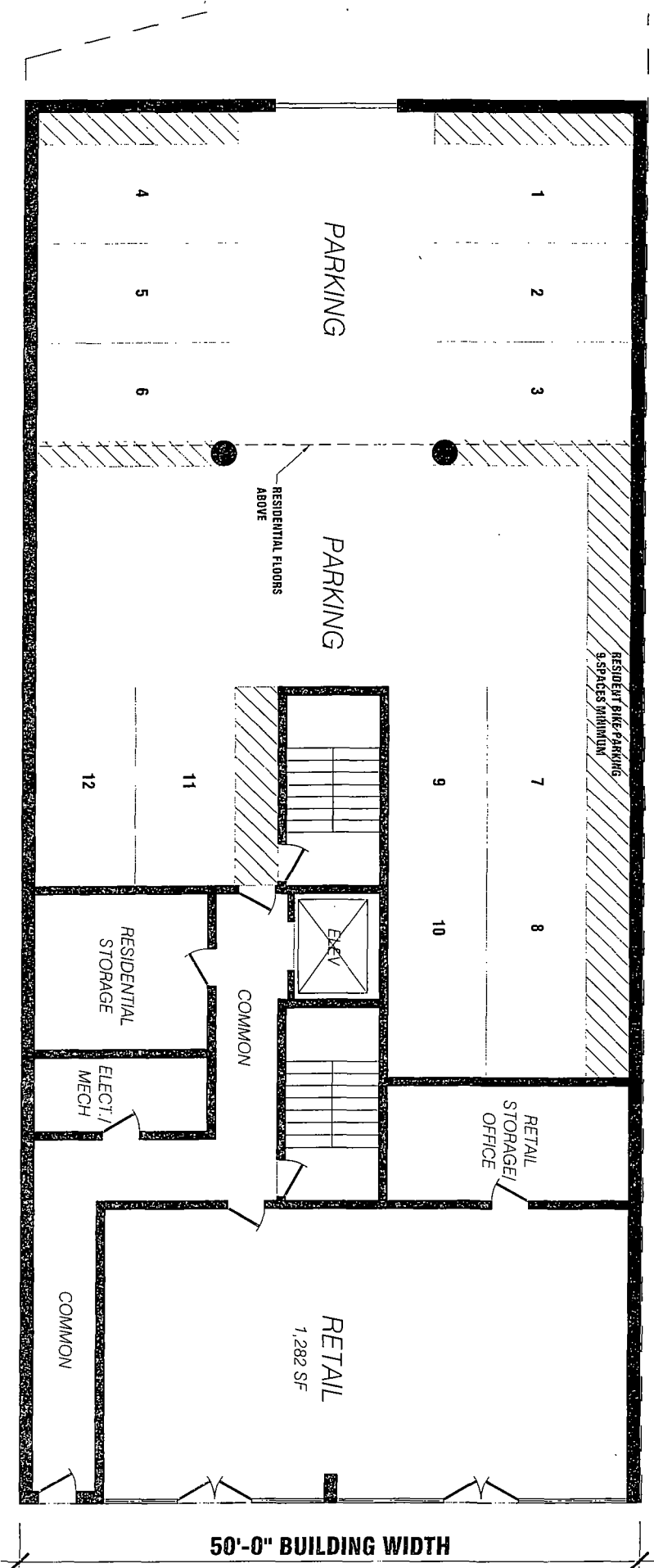


BUILDING SECTION

 PER CHICAGO ZONING CODE



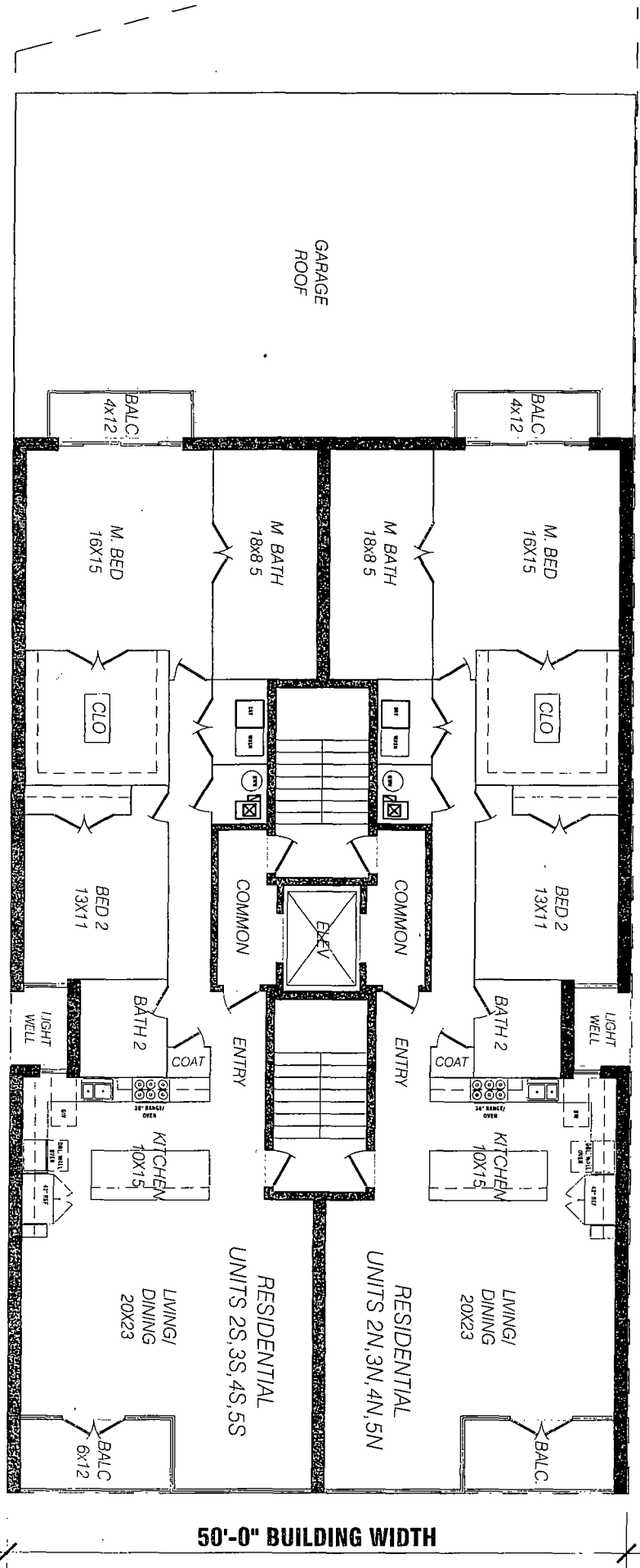

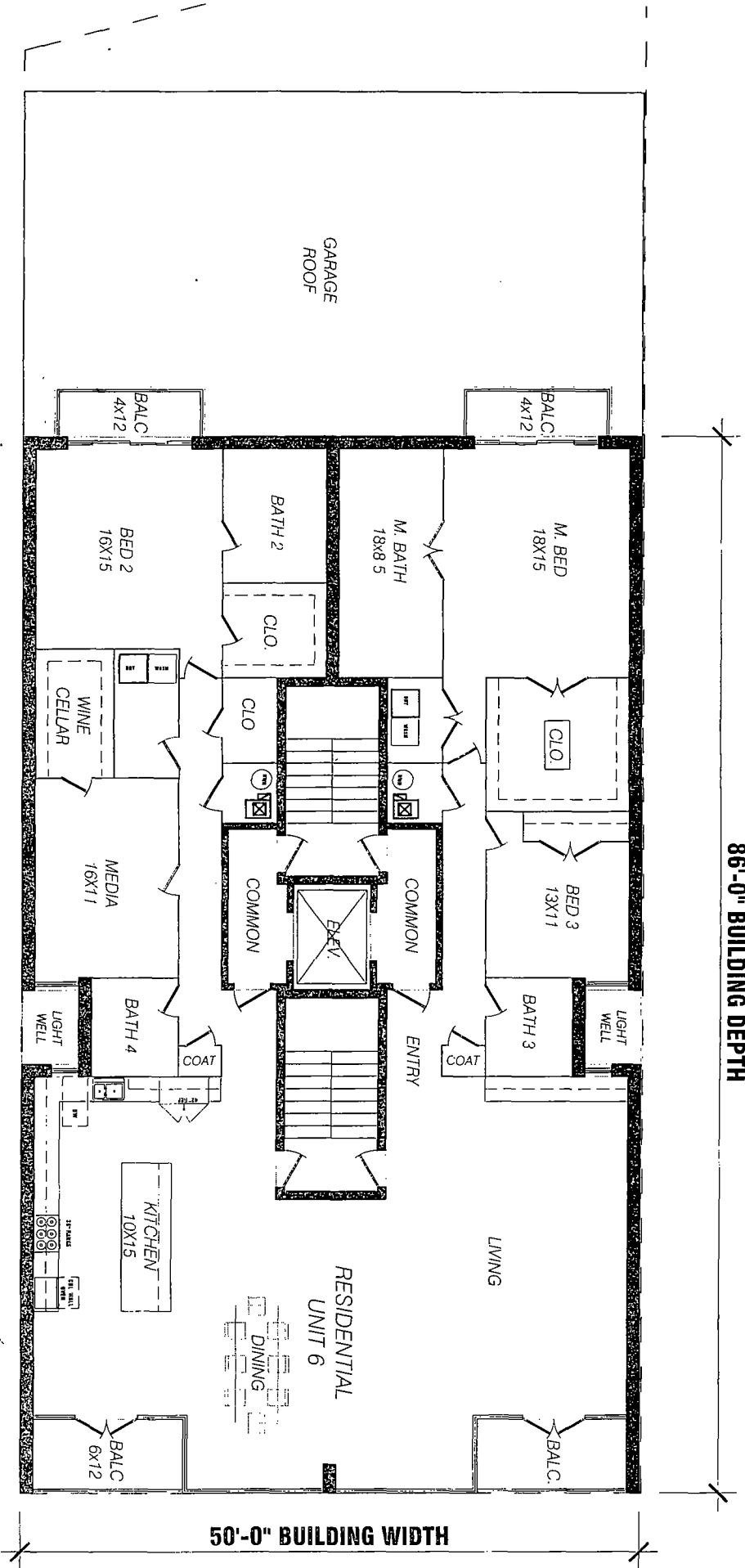
