To those of a RM 4.5 Residential Multi-Unit District, and a corresponding use district is hereby established in the area above described.

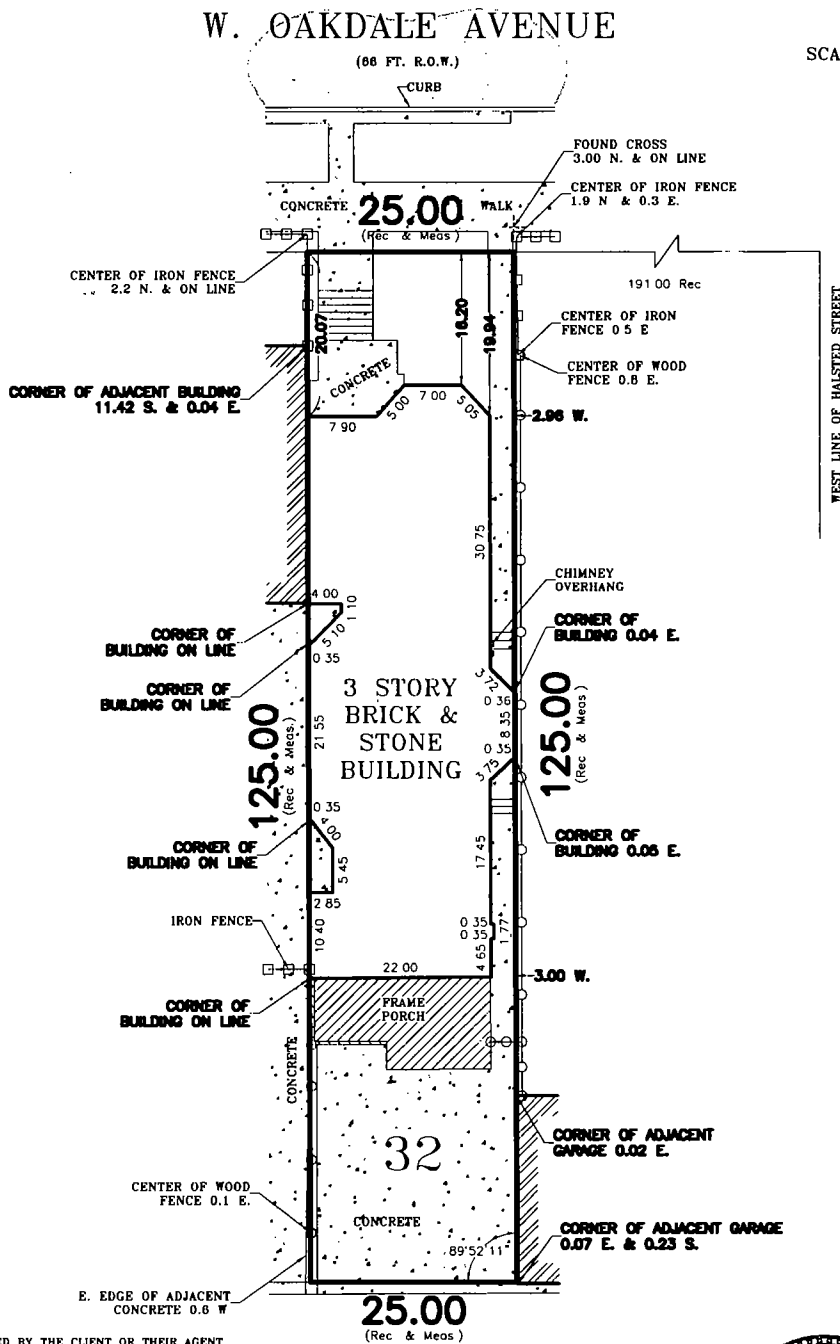
