ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Section 2 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

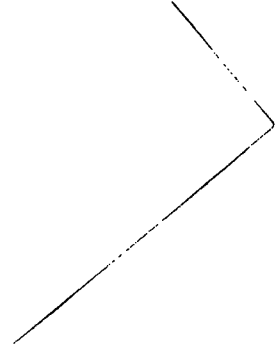
SECTION 2. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023 (19.41 through 19.69), as follows:

4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021(c), no additional package goods license shall be issued for any premises located within the following areas:

- (19.50) On 111th Street, from Kilbourn Avenue to Kostner Avenue.
- (19.51) On 111th Street, from Kostner Avenue to Pulaski Road.
- (19.52) On 111th Street, from Pulaski Road to Springfield Avenue.
- (19.53) On 111th Street, from Springfield Avenue to Lawndale Avenue.
- (19.54) On 111th Street, from Lawndale Avenue to Central Park Avenue.
- (19.55) On 111th Street, from Central Park Avenue to St. Louis Avenue.


