To those of a B2-2, Neighborhood Mixed-Use District

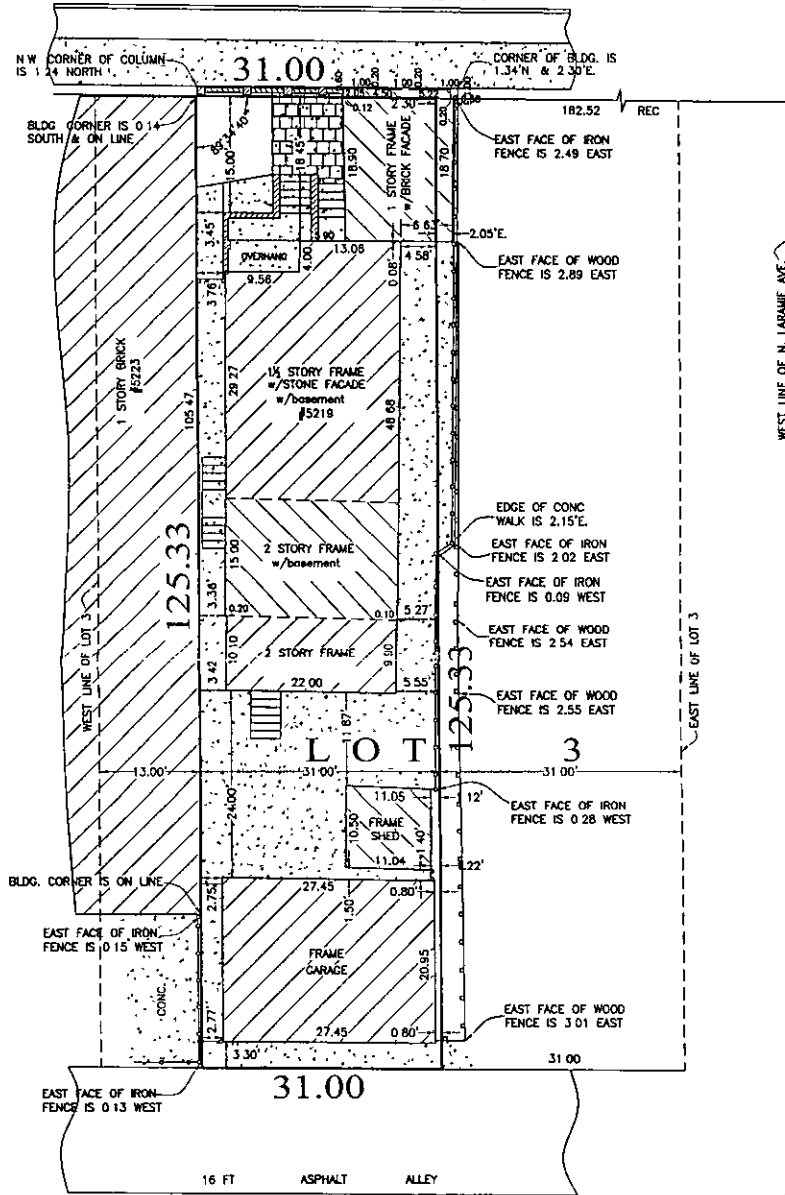
