ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District, as shown on Map 3-H in the area bounded by:

North Paulina Street, a line 24 feet North of West Beach Avenue, the alley West and parallel to North Paulina Street and a line 48 feet North of West Beach Avenue.

To those of **RM-4.5** Residential Multi-Unit District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

**NARRATIVE AND PLANS
FOR THE PROPOSED REZONING
AT
1428 NORTH PAULINA STREET**

The Application is to change zoning for 1428 North Paulina Street from RT-4 Residential Two-Flat, Townhouse and Multi-Unit District to RM-4.5, Residential Multi-Unit District. The Applicant intends to construct a four-story, three (3) dwelling unit building with basement. There will be three parking spaces at the rear of the property. The footprint of the building will be 19 feet by 57 feet 4 inches in size. The building height shall be 44 feet 10 inches high, as defined by City Code.

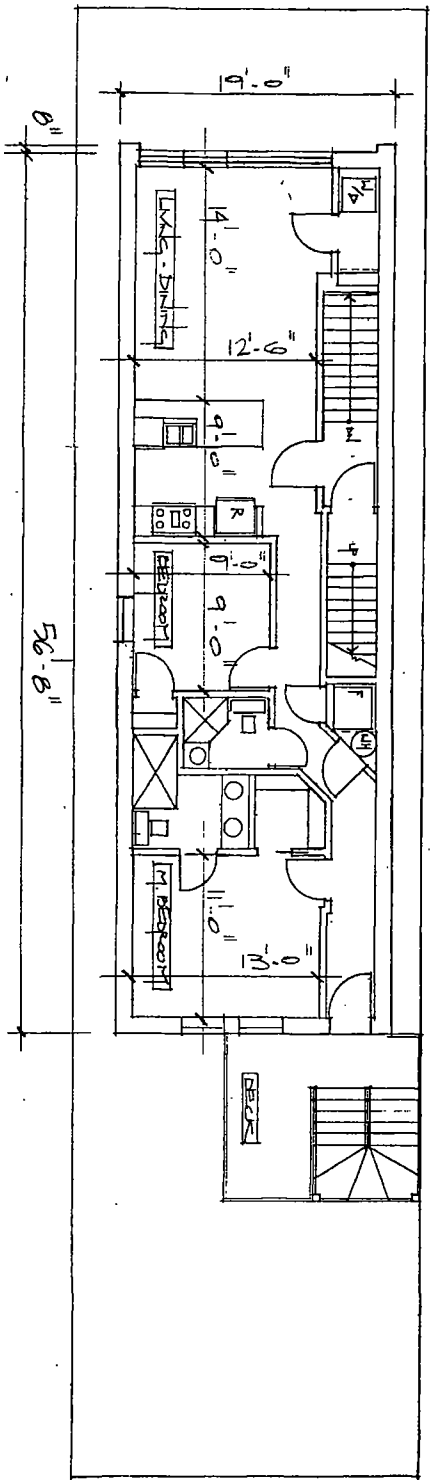
○ PART FLOOR PLAN

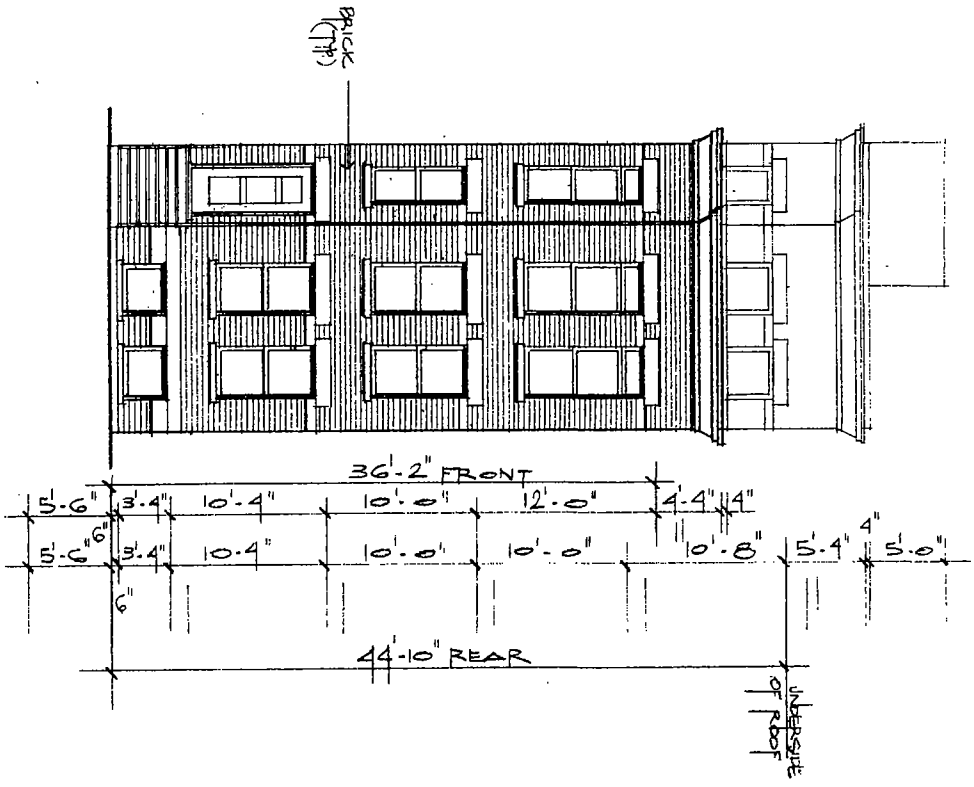
