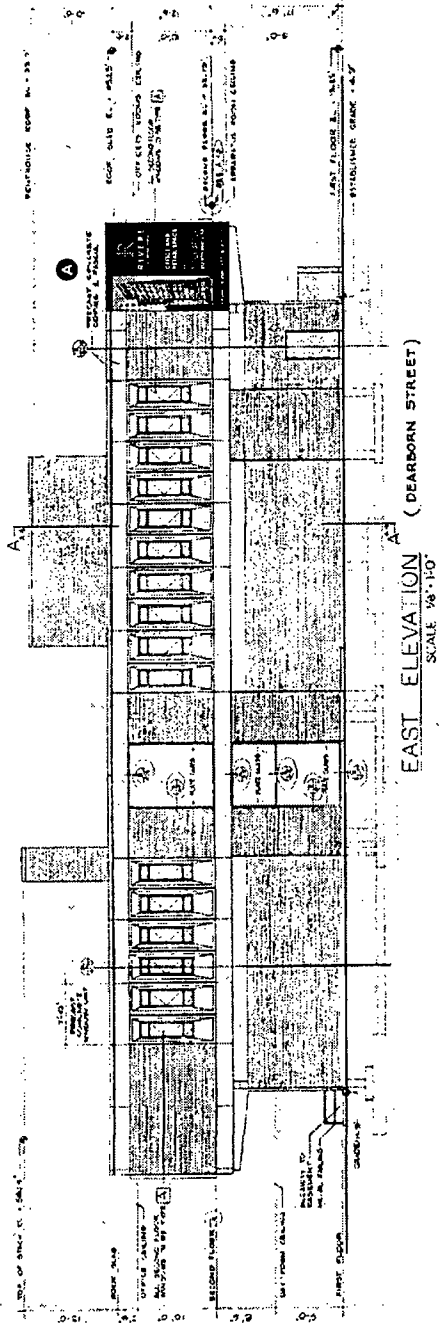

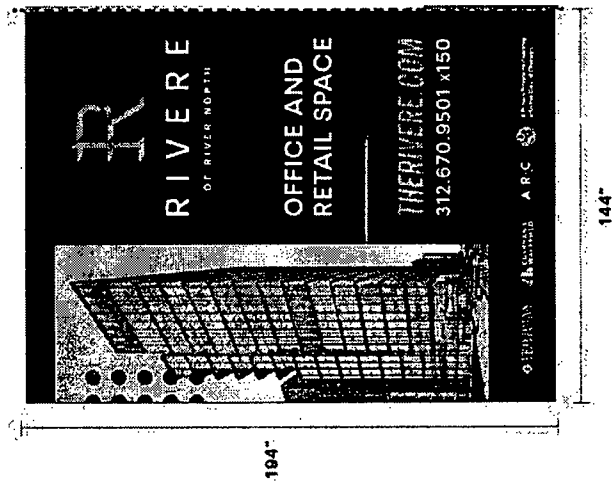

SCALE 1/8" = 1'-0"

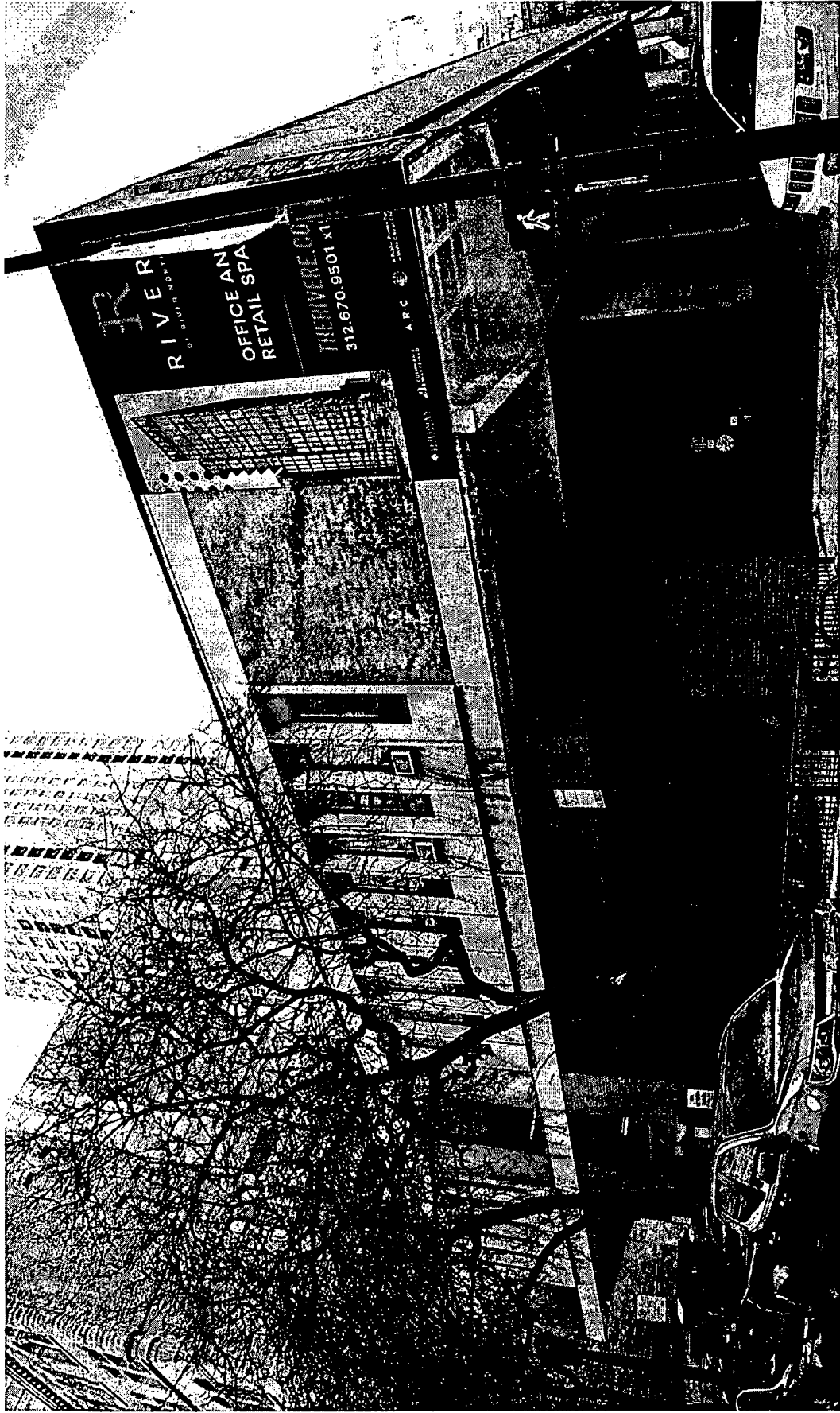
NORTHEAST CORNER




