**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**


**Section 1:**

The ordinance passed by the City Council of the City of Chicago for PUBLICAN ANKER on **04/10/2019**, and printed upon page **99852** of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words "PUBLICAN ANKER; sidewalk cafe area #1 shall be forty point five (40.5) feet in length and five (5) feet in width for a total of two hundred two point five (202.5) square feet; seating capacity 20" and inserting in their place the words "CAFÉ CANCALE; sidewalk cafe area #1 shall be thirty point nine-two (30.92) feet in length and five point nine-two (5.92) feet in width for a total of one hundred eighty three point five (183.05) square feet; seating capacity 10"
