BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

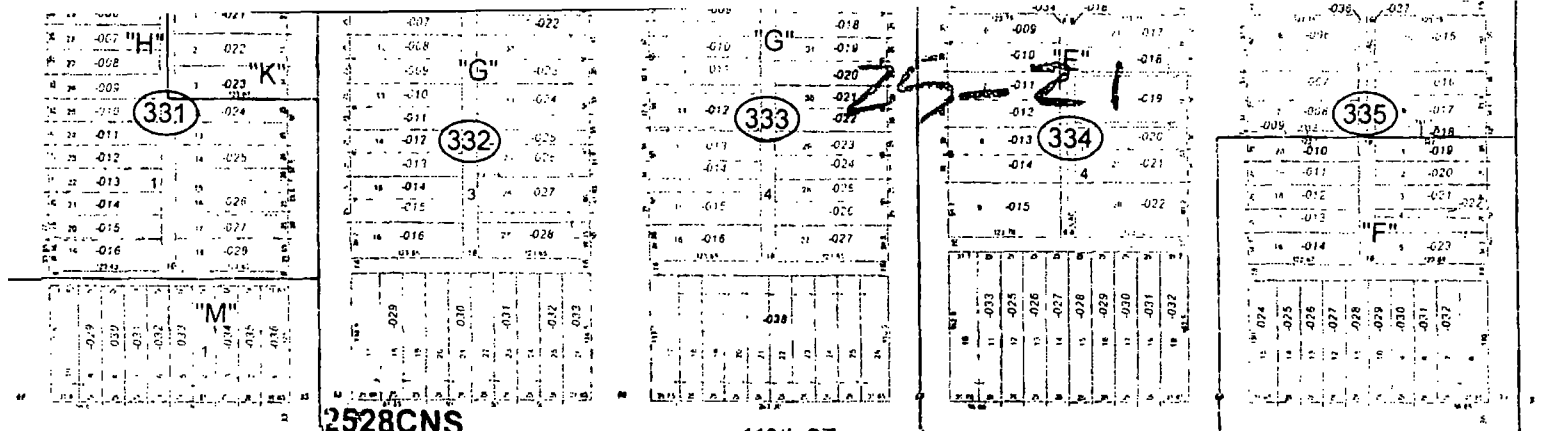
SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 30-F in the area bounded by

the public alley next north of and parallel to West 120th Street; South Normal Avenue; West 120th Street; and South Parnell Avenue,

to those of a RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District.

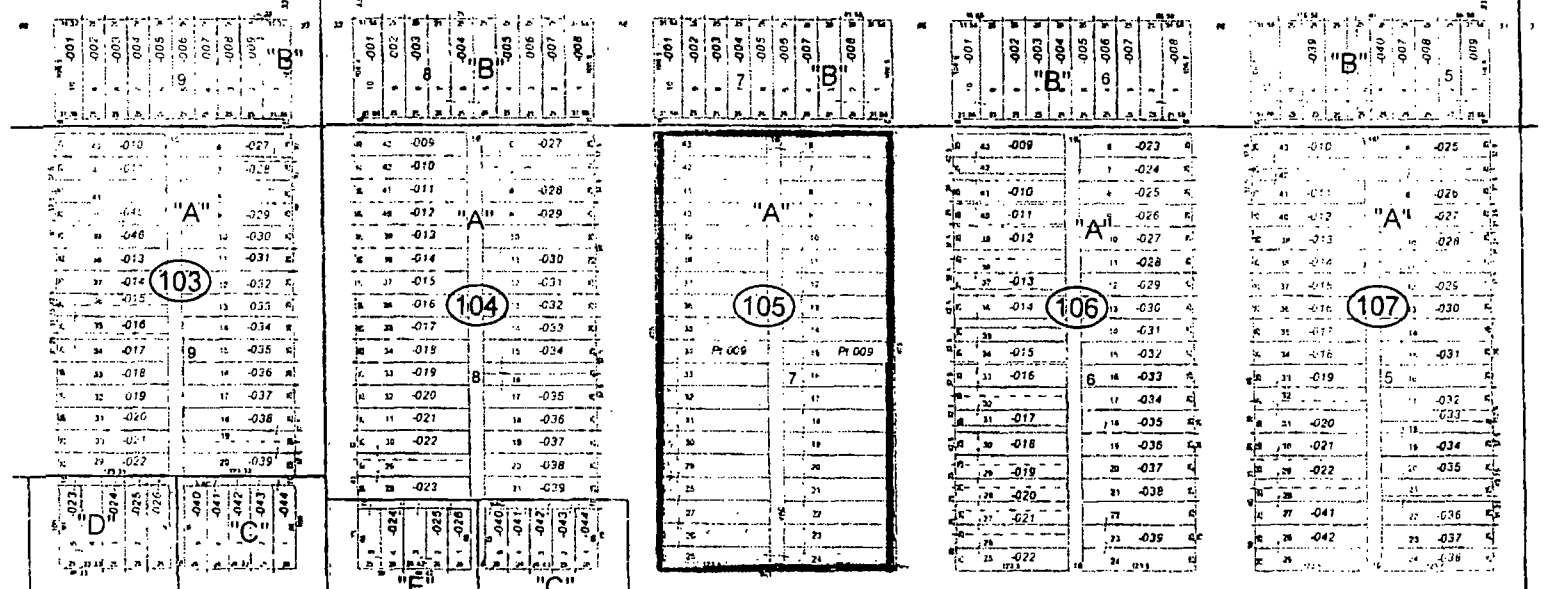
SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The existing building is 1 to 3 stories in height, 63.35 feet above grade at its highest point. There will be no commercial space.
