ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS2 Residential Single–Unit (Detached House) District symbols as shown on Map No. 11-M in the area bounded by:

A line 215.56 feet north of and parallel to West Montrose Avenue; North Austin Avenue; the public alley next north of and parallel to West Montrose Avenue; and the public alley next west of and parallel to North Austin Avenue.

To those of a B2-3, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and due publication.
