ORDINANCE CAFE MED Acct. No. 328936 - 1 Permit No. 1095603

Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to CAFE MED upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 198 E. Delaware Pl.. Said sidewalk cafe area #1 shall be ten point six seven (10.67) feet in length and five point six seven (5.67) feet in width, area #2 shall be thirty-two point one seven (32.17) feet in length and thirteen point three seven (13.37) feet in width, area #3 shall be twenty-two point three three (22.33) feet in length and seventeen point nine two (17.92) feet in width, area #4 shall be eleven point five eight (11.58) feet in length and fourteen point three three (14.33) feet in width for a total of one thousand fifty-six point seven one (1056.71) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along E. Delaware Place. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday through Thursday 8:00 a.m. to 10:00 p.m.□Friday through Sunday 8:00am to 11:00pm

Compensation: \$2,430.43 SEATING CAPACITY: 41

Sidewalk Cafe Permit and approved plan must be posted at all times.

\*Sidewalk Cafes shall not operate earlier than 8:00 AM, nor later than 11:00 PM.

This grant of privilege #1095603 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900 though 10-28-995 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.


