ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District, as shown on Map 3-G in the area bounded by:

West Thomas Street; a line 490.50 feet East of North Ashland Avenue; the alley next South of and parallel to West Thomas Avenue; and a line 465.50 feet East of North Ashland Avenue.

To those of **RM-4.5 Residential Multi-Unit District.**

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

FOR THE PROPOSED REZONING

1513 WEST THOMAS STREET**

The Application is to change zoning for 1513 West Thomas Street from RS-3 Residential Single-Unit (Detached House) District to RM-4.5 Residential Multi-Unit District. This zoning change is for purposes to allow Applicant to construct a three-story, three dwelling unit building with a basement. There will be a three-car garage at the rear of the property. The footprint of the building shall be approximately be 20 feet by 74 feet 8 inches in size. The building height shall be 37 feet 8 inches high, as defined by code.

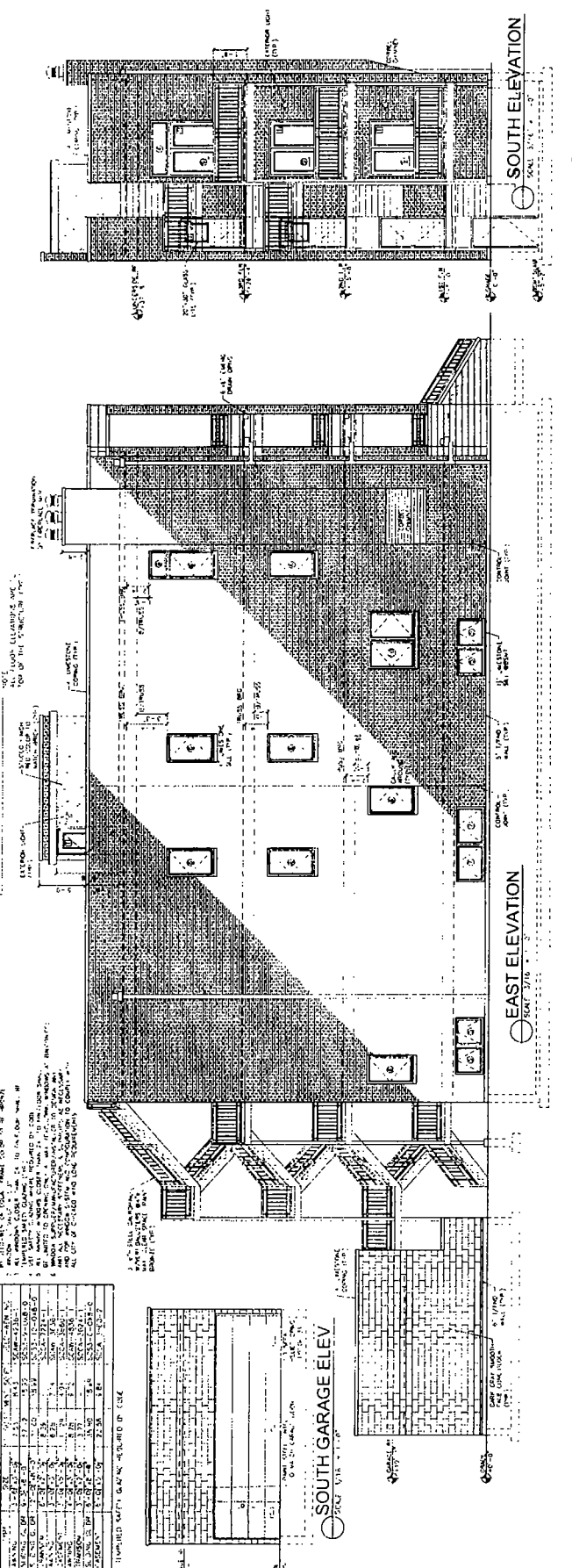


NORTH ELEVATION
