Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to GOLUB & COMPANY, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 680 N. Lake Shore Dr..

Said Canopy(s) at N. Lake Shore Dr. measure(s):

One (1) at twenty-seven (27) feet in length, and twenty-one (21) feet in width for a total of five hundred sixty-seven (567) square feet.

Said Canopy(s) at Mc Clurg measure(s):

One (1) at thirteen (13) feet in length, and fifteen (15) feet in width for a total of one hundred ninety-five (195) square feet.

Said Canopy(s) at E. Huron measure(s):

One (1) at twenty-six (26) feet in length, and sixteen (16) feet in width for a total of four hundred sixteen (416) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1097948 herein granted the sum of one hundred fifty-three (\$153.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

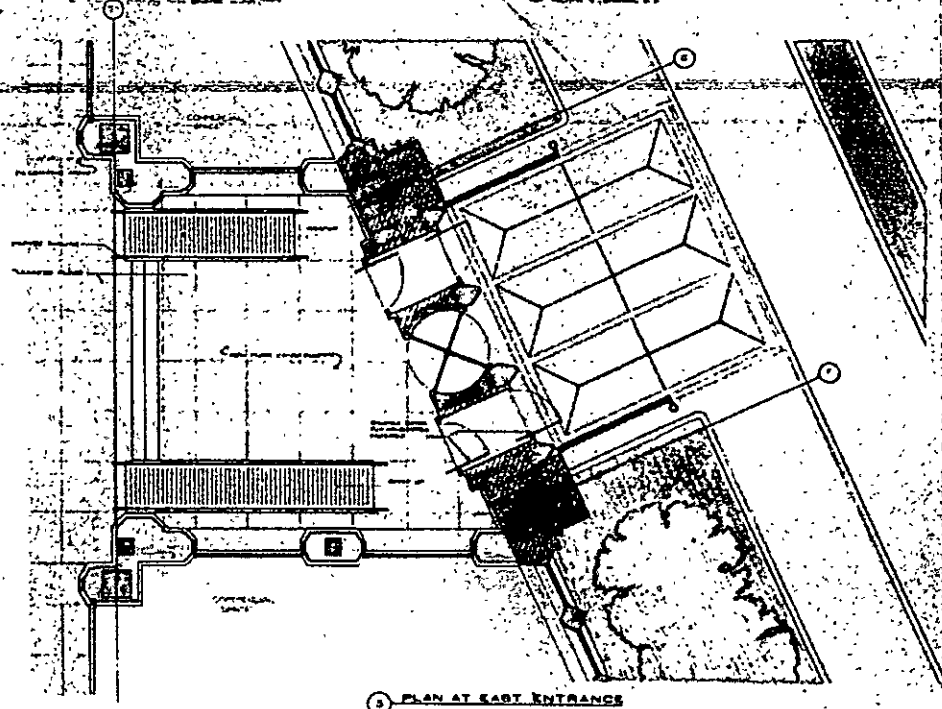
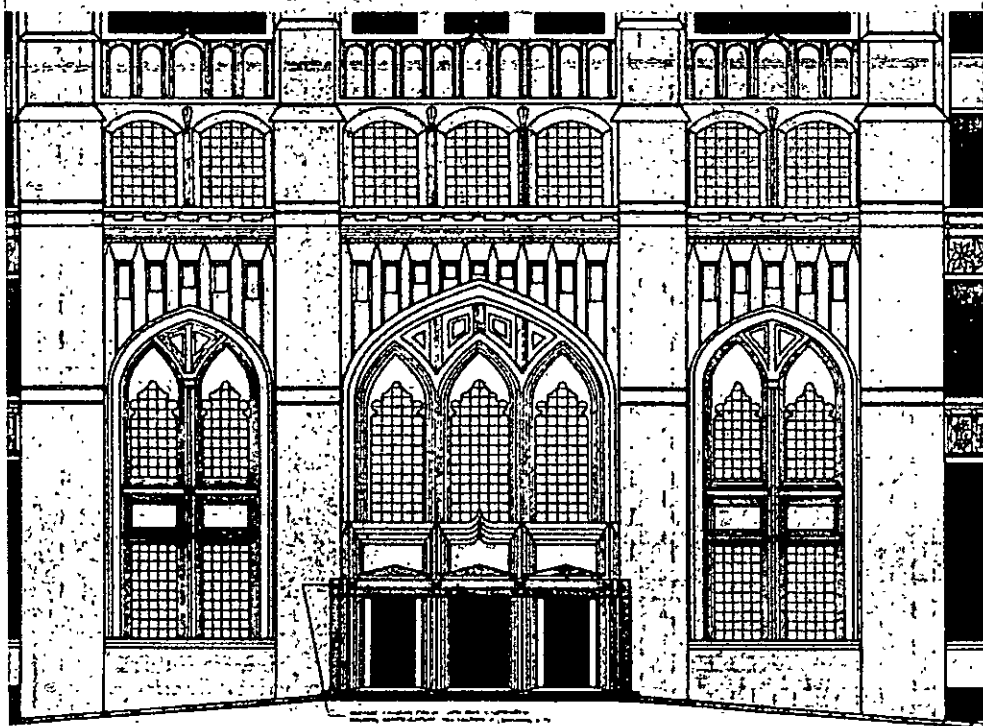
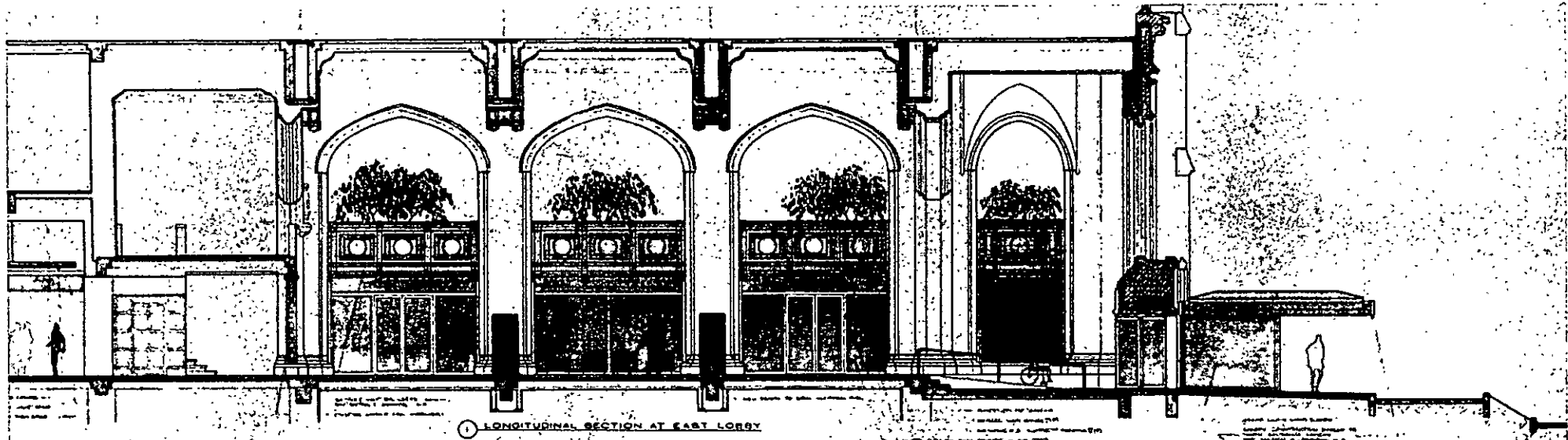
