## ORDINANCE

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the *B3-2 Community Shopping District* symbols and indications as shown on Map No. 11-H in the area bounded by

a line 339.50 feet north of and parallel to West Cullom Avenue; the alley next east of and parallel to North Western Avenue; a line 314.60 feet north of West Cullom Avenue; and North Western Avenue,

to those of a *B2-3 Neighborhood Mixed-Use District*.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.
