ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 16-G in the area bounded by:

The public alley next north and parallel to West 69th Street; a line 125.00 feet east of and parallel to South Bishop Street; West 69th Street; and a line 75.00 feet east of and parallel to South Bishop Street

to those of an B3-1 Community Shopping District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

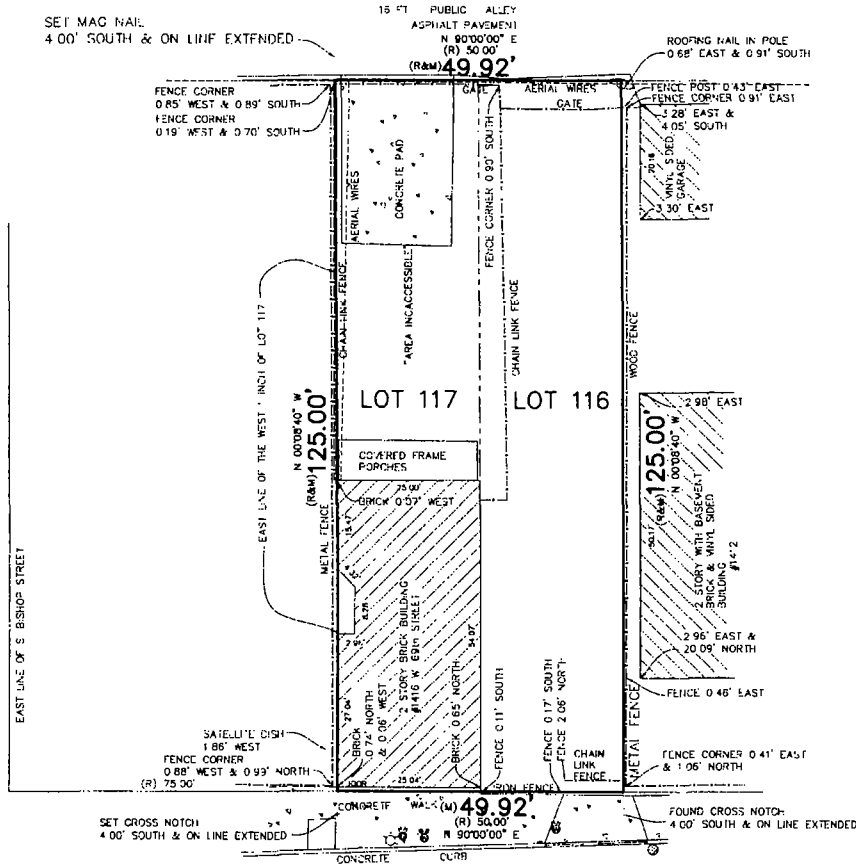
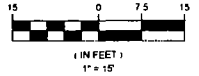
