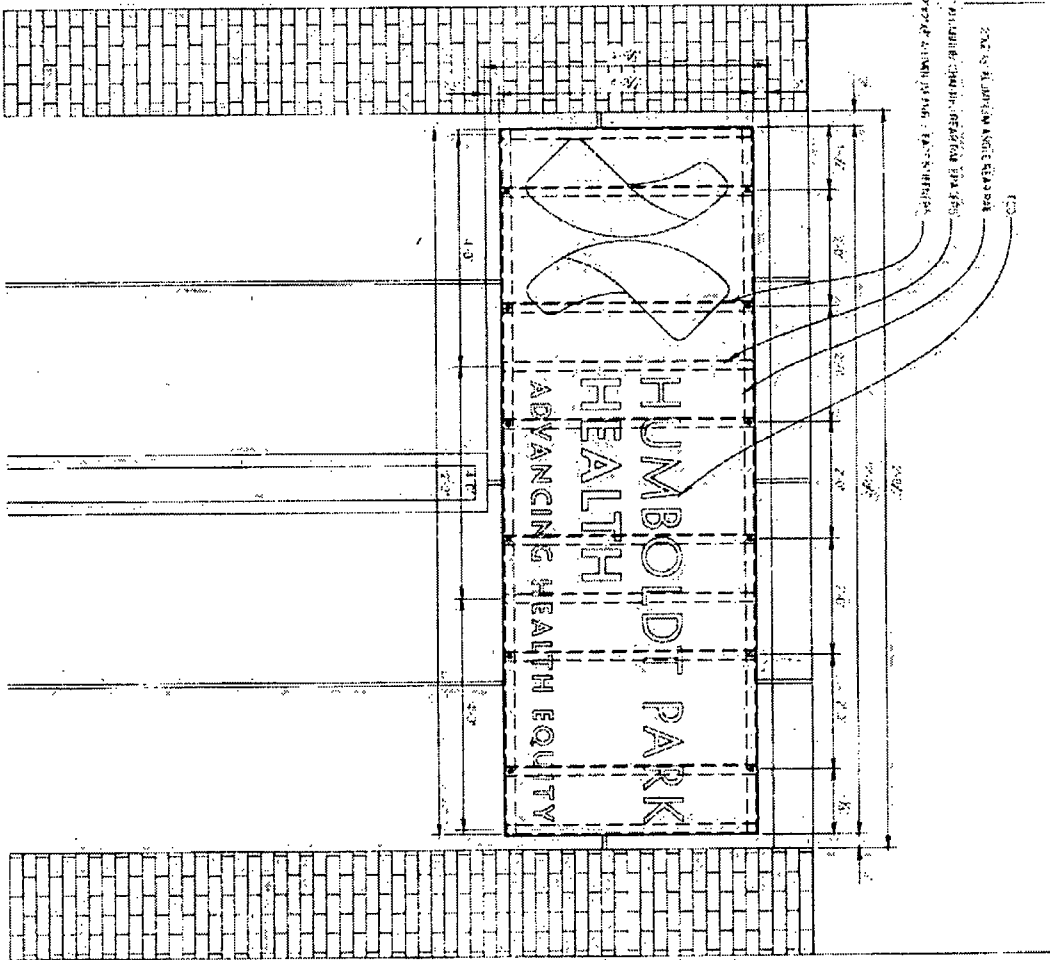

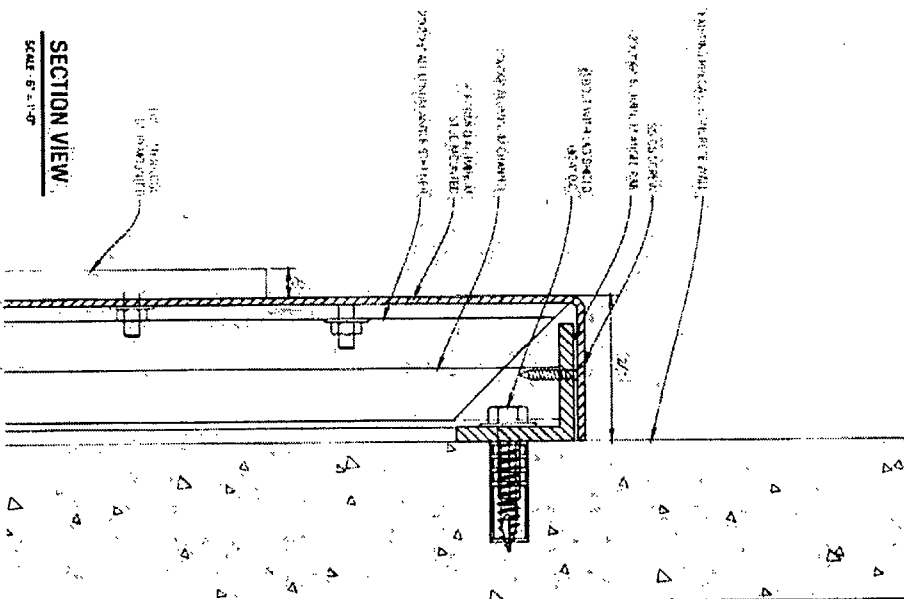

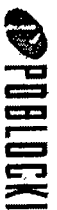


**FRONT ELEVATION**
