ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 6-I in the area bounded by

A perpendicular line to South Kedzie Avenue 336 feet north of and parallel to West 25th street; the public alley next west of and parallel to South Troy Street; a perpendicular line to South Kedzie Avenue 288 feet north of and parallel to West 25th Street; and South Kedzie Avenue

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

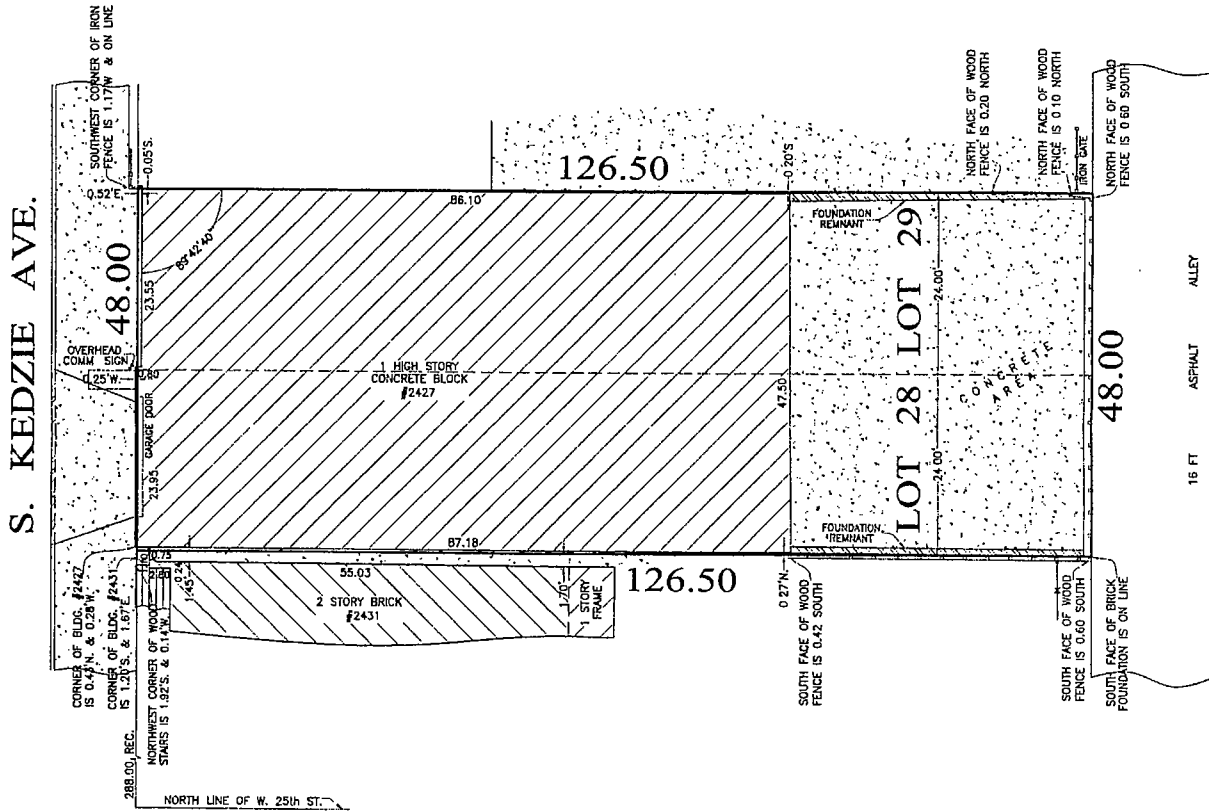

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about October 24 , 2017 the undersigned will file an application for a change in zoning from B3-2 zoning district to a C1-2 zoning district on behalf of VIP Real Estate LTD. for the property located at 2427-29 S. Kedzie Avenue, Chicago, Il 60623.


The Applicant is proposing to re-use existing vacant commercial building and land in order to operate a hand car wash. The Applicant intends to keep the commercial use of the land. 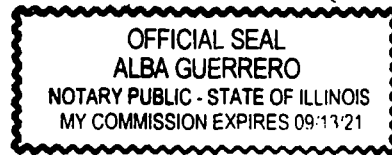

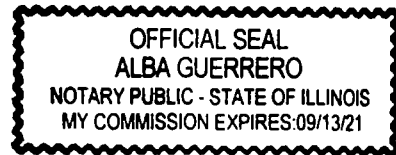
