Be it Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to FORTUNA MARKET, GRILL, & DELI upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 2706 W. Peterson Ave.. Said sidewalk cafe area #1 shall be twenty-five (25) feet in length and seven (7) feet in width, area #2 shall be fifteen (15) feet in length and five (5) feet in width for a total of two hundred fifty (250) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along W. Peterson. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday 10:00am until 6:00pm Monday through Saturday 9:00am until 7:30pm
Compensation: \$600.00
SEATING CAPACITY: 28

Sidewalk Cafe Permit and approved plan must be posted at all times.

This grant of privilege #1096384 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900 through 10-28-995 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.


