*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to GATEWAY RETAIL PROPERTY, LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, twenty-five (25) Caisson(s) under the public right-of-way adjacent to its premises known as 14-40 S. Halsted St..

Said Caisson(s) at S. Halsted Street measure(s):

One (1) at one (1) foot in length, and fifteen point eight (15.8) feet in width for a total of fifteen point eight (15.8) square feet. Existing caisson is approximately sixty-five (65) feet in depth.

Said Caisson(s) at S. Halsted Street measure(s):

Five (5) at one (1) foot in length, and five (5) feet in width for a total of twenty-five (25) square feet. Existing caissons are approximately sixty-five (65) feet in depth.

Said Caisson(s) at S. Halsted Street measure(s):

One (1) at one (1) foot in length, and two point two (2.2) feet in width for a total of two point two (2.2) square feet. Existing caisson is approximately sixty-five (65) feet in depth.

Said Caisson(s) at W. Monroe Street measure(s):

Three (3) at one (1) foot in length, and one point one (1.1) foot in width for a total of three point three (3.3) square feet. Existing caissons are approximately sixty-five (65) feet in depth.

Said Caisson(s) at W. Monroe Street measure(s):

Two (2) at one (1) foot in length, and four point eight (4.8) feet in width for a total of nine point six (9.6) square feet. Existing caissons are approximately sixty-five (65) feet in depth.

Said Caisson(s) at W. Monroe Street measure(s):

One (1) at one (1) foot in length, and twelve point nine (12.9) feet in width for a total of twelve point nine (12.9) square feet. Existing caisson is approximately sixty-five (65) feet in depth.

Said Caisson(s) at W. Monroe Street measure(s):

One (1) at one (1) foot in length, and one point three (1.3) foot in width for a total of one point three (1.3) square feet. Existing caisson is approximately sixty-five (65) feet in depth.

Said Caisson(s) at W. Monroe Street measure(s):

One (1) at one (1) foot in length, and seventeen point seven (17.7) feet in width for a total of seventeen point seven (17.7) square feet. Existing caisson is approximately sixty-five (65) feet in depth.

Said Caisson(s) at W. Monroe Street & S. Green Street measure(s):

One (1) at one (1) foot in length, and thirteen point eight (13.8) feet in width for a total of thirteen point eight (13.8) square feet. Existing caisson is approximately sixty-five (65) feet in depth.

Said Caisson(s) at S. Green Street measure(s):

Two (2) at one (1) foot in length, and nine point three (9.3) feet in width for a total of eighteen point six (18.6) square feet. Existing caissons is approximately sixty-five (65) feet in depth.

Said Caisson(s) at S. Green Street measure(s):

Five (5) at one (1) foot in length, and five point five (5.5) feet in width for a total of twenty-seven point five (27.5) square feet. Existing caissons are approximately sixty-five (65) feet in depth.

Said Caisson(s) at S. Green Street measure(s):

One (1) at one (1) foot in length, and two point six (2.6) feet in width for a total of two point six (2.6) square feet. Existing caisson is approximately sixty-five (65) feet in depth.

Said Caisson(s) at S. Green Street measure(s):

One (1) at one (1) foot in length, and three point nine (3.9) feet in width for a total of three point nine (3.9) square feet. Existing caisson is approximately sixty-five (65) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1129110 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

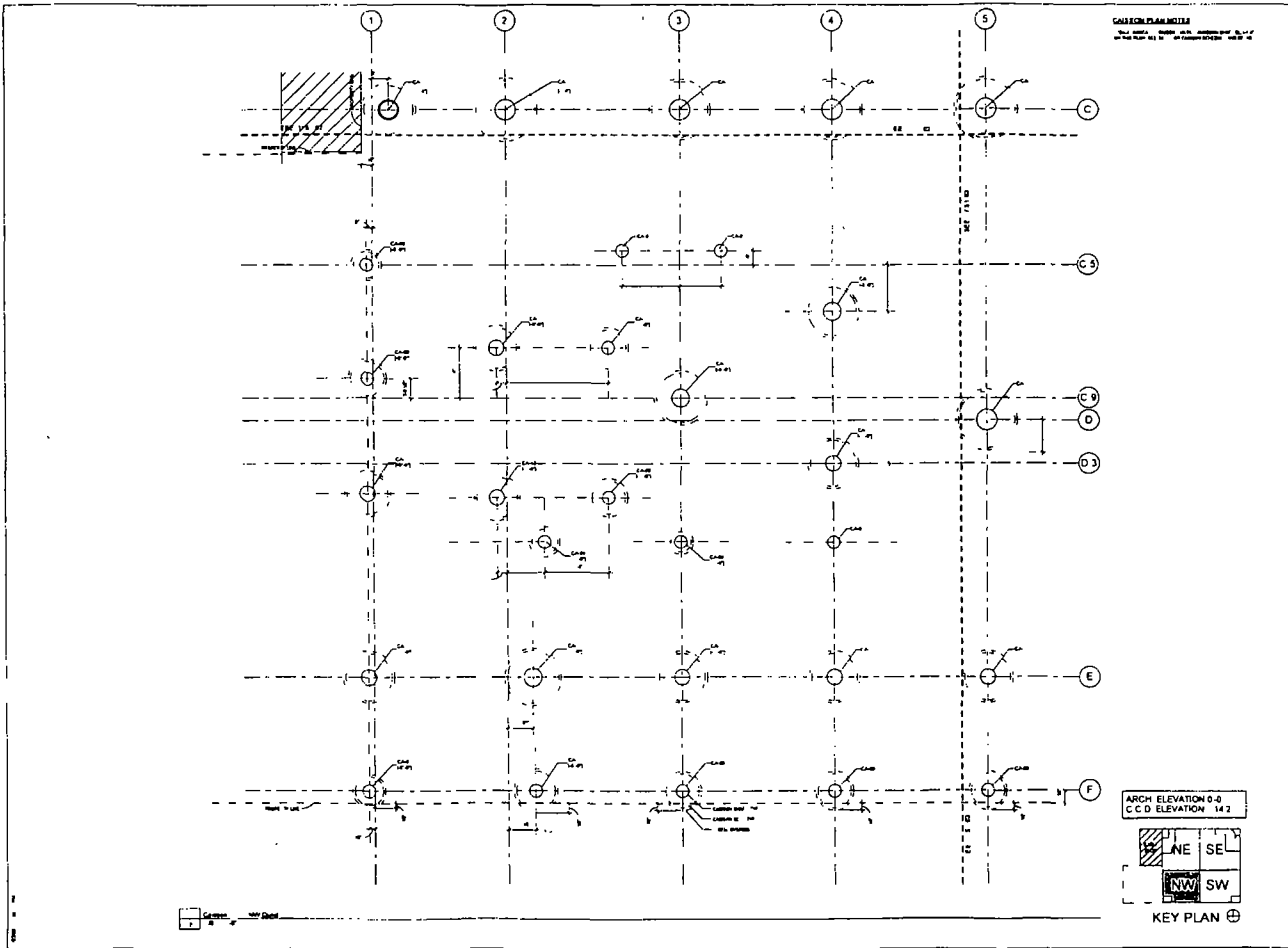
