Your Committee on Pedestrian and Traffic Safety begs leave to recommend that Your Honorable Body Do Not Pass the sundry proposed ordinances and orders submitted herewith, which were referred to the committee concerning traffic regulations and traffic signs, et cetera, as follows:

#### WARD PARKING PROHIBITED AT ALL TIMES – DISABLED:

- 8 8343 S. Dorchester, Disabled Permit 75700 – Not Recommended, Garage at requested location [O2011-4422]
- 12 3309 W. 37<sup>th</sup> Place, Disabled Permit 74897 – Five handicapped signs posted on block [O2011-4436]
- 35 2307 N Hamlin, Disabled Permit 73398 – Not Recommended, Insufficient corner clearance [O2011-4384]



- 4 Amend ordinance passed 12/22/54, page 9131 which reads: South Kenwood Avenue from East 51<sup>st</sup> Street to East 59<sup>th</sup> Street, 5 Ton Load Limit, by striking East 51<sup>st</sup> Street and inserting East 53<sup>rd</sup> Street – Request withdrawn by Alderman – 11-00467423 [O2011-853]
