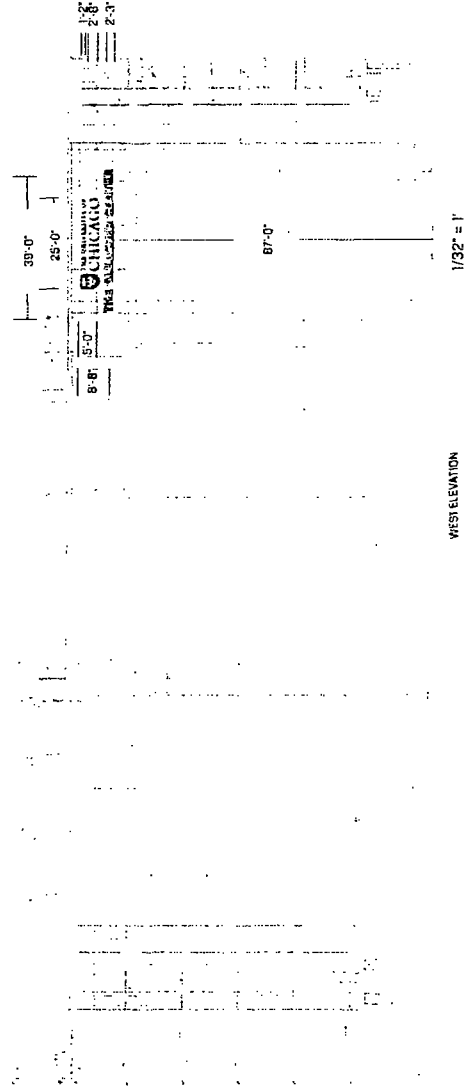


EXISTING
