

**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Pursuant to an ordinance passed by the City Council of the City of Chicago on the third day of December 1984, printed on pages 11459-11460 of the Journal of the Proceedings of said date, which authorizes the erection of honorary street-name signs, the Commissioner of Transportation shall take the necessary action for the standardization of 100 N. Carpenter Street, to be known as "OPRAH WINFREY WAY."

**SECTION 2.** This ordinance shall be in full force and effect upon passage and publication.
