Be It Ordained by the City Council of the City of Chicago

SECTION 1 Permission and authority are hereby given and granted to CANAL CROSSING CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use seven (7) Awning(s) projecting over the public right-of-way adjacent to its premises known as 2322 S Canal St

Said Awning(s) at S CANAL ST measure(s)

Four (4) at nine point five eight (9 58) feet in length, and two (2) feet in width for a total of seventy-six point six four (76 64) square feet

Said Awning(s) at E 23RD PL measure(s)

Three (3) at nine point five eight (9 58) feet in length, and two (2) feet in width for a total of fifty-seven point four eight (57 48) square feet

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago

The grantee shall pay to the City of Chicago as compensation for the privilege #1097791 herein granted the sum of one hundred seventy-five (\$175 00) per annum in advance

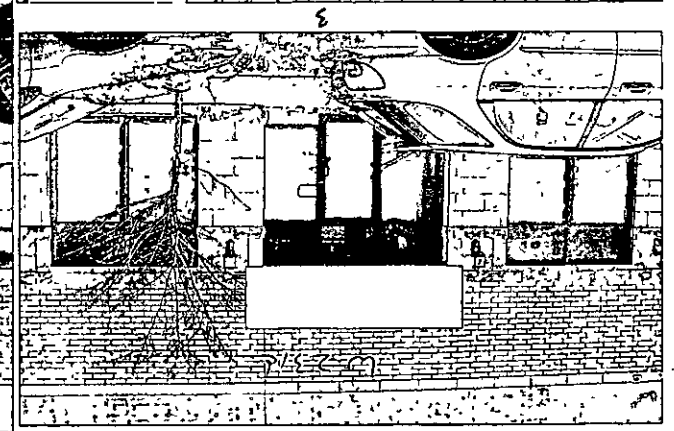
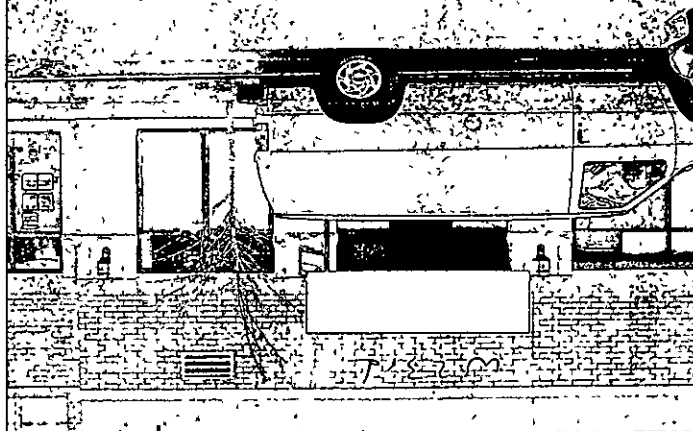
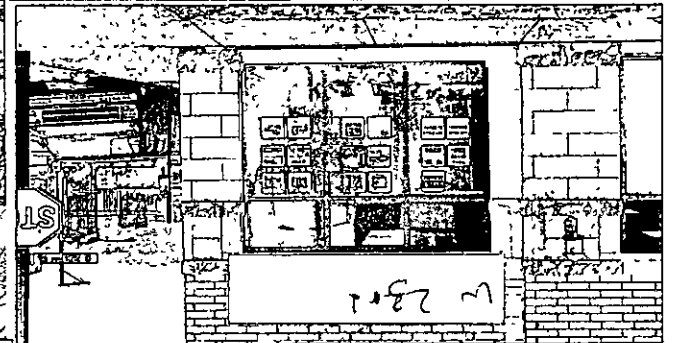
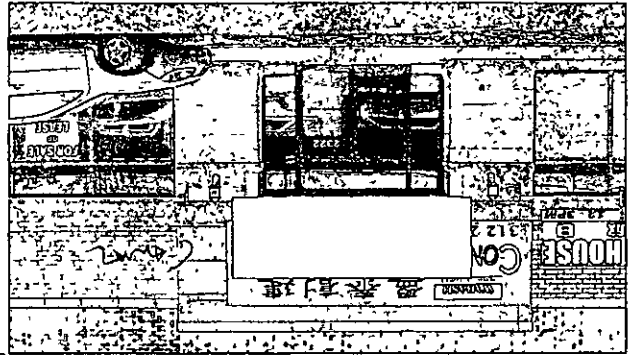
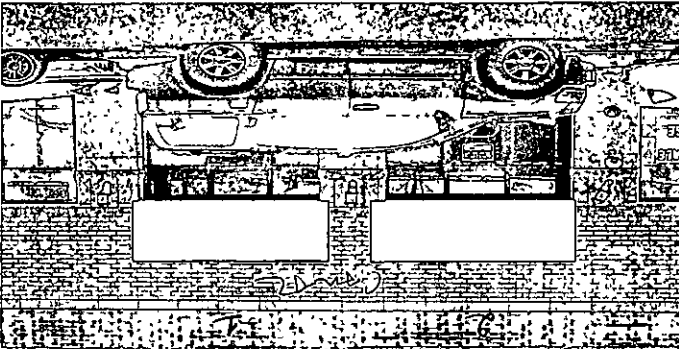
A 25% penalty will be added for payments received after due date
