*Se It Ordained by the City Council of the City of Chicago:*

Permission and authority are hereby given and granted to DUBLIN BAR & GRILL upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 1050 N. State St.. Said sidewalk cafe area #1 shall be forty-one (41) feet in length and eleven (11) feet in width, area #2 shall be sixteen (16) feet in length and two (2) feet in width for a total of four hundred eighty-three (483) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along W. MAPLE ST., N. STATE ST.. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday thru Sunday 11:00 a.m. to 11:00 p.m.  
Compensation: \$1,110.90  
SEATING CAPACITY: 48


Sidewalk Cafe Permit and approved plan must be posted at all times.

\* Sidewalk Cafes shall not operate earlier than 8:00 AM, nor later than 11:00 PM.

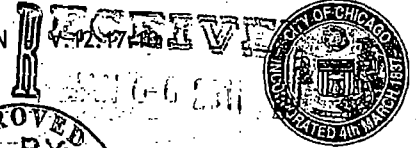

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
