ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map Number 9-G in the area bounded by:

West Henderson Street; a line parallel to and 25.00 feet east of the east line of the right of way of North Greenview Avenue; the public alley parallel to and north of West Henderson Street; and a line parallel to and 50.00 feet east of the east line of the right of way of North Greenview Avenue

to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

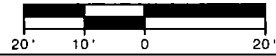

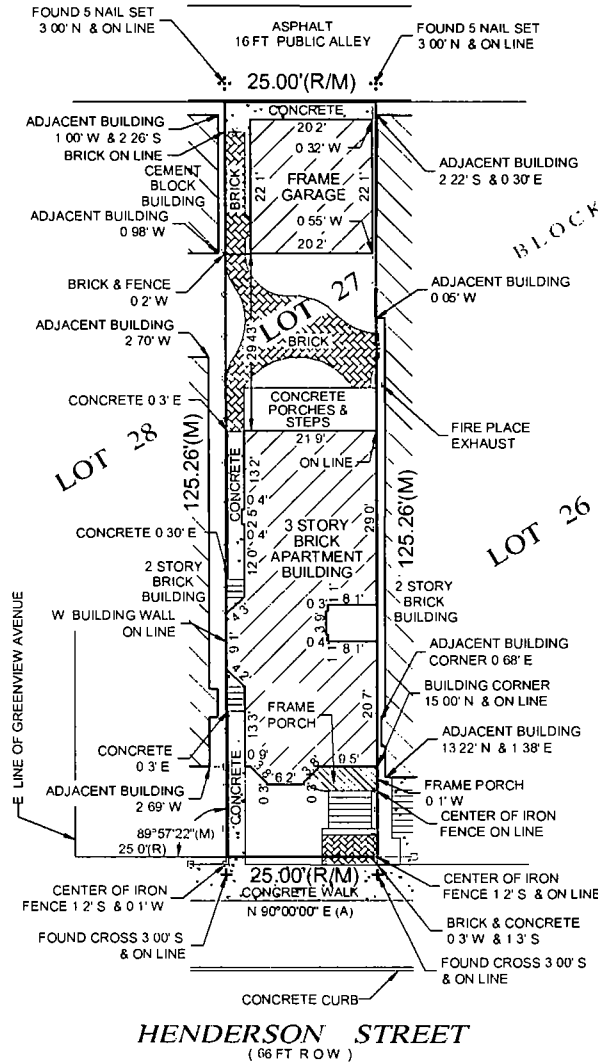

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on July 7, 2016, the undersigned filed an application for a change in zoning from RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District to RT-4 Residential Two-Flat, Townhouse and Multi-Unit District on behalf of the applicant-owners, **Javier Mendoza and Eleanor Mendoza**, for the property located at 1454 W. Henderson Street.

The applicant-owners presently reside at the subject property, which is improved with a two-story masonry building containing two dwelling units.
