AN ORDINANCE OF THE CITY OF CHICAGO, ILLINOIS AUTHORIZING THE CONVEYANCE OF CITY LAND TO THE PUERTO RICAN CULTURAL CENTER

WHEREAS, the City of Chicago ("<u>City</u>") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City has established the Community Development Commission ("<u>CDC</u>") to, among other things, designate redevelopment areas, approve redevelopment plans, and recommend the sale of parcels located in redevelopment areas, subject to the approval of the City Council; and

WHEREAS, pursuant to an ordinance adopted by the City Council of the City (the "<u>City</u> <u>Council</u>") on March 10, 1999, and published at pages 90909-90926, inclusive, of the Journal of Proceedings of the City Council (the "Journal") for such date, the City Council approved a certain redevelopment plan (the "<u>Redevelopment Plan</u>") for the Greater Humboldt Park Redevelopment Area (the "<u>Redevelopment Area</u>") pursuant to Chapter 2-124-010 of the Municipal Code of the City, which Redevelopment Plan was subsequently amended pursuant to an ordinance adopted by the City Council on November 3, 1999 and published at pages 13967-13979, inclusive, of the Journal for such date; and

WHEREAS, pursuant to an ordinance adopted by the City Council on June 27, 2001, and published at pages 62056-62192, inclusive, of the Journal for such date, the City Council approved a certain redevelopment plan and project (the "<u>TIF Plan</u>") for the Humboldt Park Commercial Redevelopment Project Area (the "<u>TIF Area</u>") pursuant to the Illinois Tax Increment Allocation Redevelopment Act, as amended (65 ILCS 5/11-74.4-1 et seq.) (the "<u>Act</u>"); and

WHEREAS, pursuant to an ordinance adopted by the City Council on June 27, 2001, and published at pages 62193-62204, inclusive, of the Journal for such date, the City Council designated the TIF Area as a redevelopment project area pursuant to the Act; and

WHEREAS, pursuant to an ordinance (the "<u>TIF Ordinance</u>") adopted by the City Council on June 27, 2001, and published at pages 62205-62215, inclusive, of the Journal for such date, the City Council adopted tax increment allocation financing pursuant to the Act as a means of financing certain redevelopment project costs (as defined in the Act) in the TIF Area incurred pursuant to the TIF Plan; and

WHEREAS, the City is the owner of the real property commonly known as 2425 West North Avenue, Chicago, Illinois 60647, which is legally described on <u>Exhibit A</u> attached hereto (the "<u>Property</u>"), and which is located in the Redevelopment Area and the TIF Area; and

WHEREAS, the Property consists of approximately 3,019 square feet (.07 acres) and is located adjacent to a building with a mural depicting the story of Puerto Rico's independence; and

WHEREAS, the mural is entitled "La Crucifixion De Don Pedro" and is the oldest Puerto Rican mural in the City; and

WHEREAS, at the request of the aldermen of the 1st and 26th wards and numerous community organizations, the City acquired the Property in December 2004 in order to preserve the mural and create a public open space for the use and enjoyment of the community; and

WHEREAS, following acquisition, the City cleared and remediated the Property and, since October 2010, has been leasing the site to the Puerto Rican Cultural Center ("<u>PRCC</u>"), a non-profit, community-based institution that has served the social and cultural needs of Chicago's Puerto Rican/Latino community since 1973; and

WHEREAS, PRCC, with assistance from the City's Greencorps Chicago program, redeveloped the Property into an active open space and community garden; and

WHEREAS, the Property is now improved with a plaza, benches, raised plant beds and an open green area, and is surrounded by ornamental and chain link fencing and gates; and

WHEREAS, the historic mural on the building wall facing the Property was restored and serves as the focal point for the community space; and

WHEREAS, PRCC has submitted a proposal to the Department of Housing and Economic Development (the "<u>Department</u>") to purchase the Property from the City for \$1.00, which is approximately \$42,000 less than its fair market value, for the preservation of the mural and maintenance of the public open space; and

WHEREAS, the City desires to convey the Property to PRCC in its "as is" condition for use as a community-managed public open space; and

WHEREAS, there is a lack of sufficient open space in the City for recreational and aesthetic uses, as documented in the comprehensive plan entitled "CitySpace: An Open Space Plan For Chicago" (the "<u>CitySpace Plan</u>"), and as a result there is a need to develop small open spaces as parks, gardens and natural areas for public use; and

WHEREAS, the conveyance of the Property to PRCC for use as public open space will help alleviate the public open space shortage and is in the best interests of the City; and

WHEREAS, by Resolution No. 10-CDC-34, adopted on September 11, 2012, the CDC recommended the sale of the Property to PRCC for \$1.00; and

WHEREAS, by Resolution No. 11-050-21 adopted on August 16, 2012, the Chicago Plan Commission approved the transfer of the Property to PRCC for \$1.00; and

WHEREAS, public notices advertising the Department's intent to enter into a negotiated sale of the Property with PRCC and requesting alternative proposals appeared in the Chicago Sun-Times on September 16, September 30 and October 14, 2012; and

WHEREAS, no other responsive proposals were received by the deadline indicated in the aforesaid notices; *now, therefore,*

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The foregoing recitals, findings and statements of fact are hereby adopted as the findings of the City Council.

SECTION 2. The City hereby approves the conveyance of the Property to PRCC in its "as is" condition for the sum of One and No/100 Dollar (\$1.00).

SECTION 3. The Mayor or his proxy is authorized to execute, and the City Clerk is authorized to attest, a quitclaim deed conveying the Property to PRCC. The quitclaim deed shall include the following covenant running with the land, or language substantially similar and acceptable to the Corporation Counsel:

PRCC shall use, or permit the use, of the Property as open space only. If PRCC uses, or permits the use, of the Property for any other purpose, the City may re-enter and take possession of the Property, terminate the estate conveyed to PRCC, and revest title to the Property in the City

SECTION 4. The Commissioner of the Department (the "<u>Commissioner</u>") or a designee of the Commissioner is each hereby authorized, with the approval of the City's Corporation Counsel as to form and legality, to negotiate, execute and deliver, or receive on behalf of the City, such other supporting documents as may be necessary or appropriate to convey the Property to PRCC.

SECTION 5. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 6. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 7. This ordinance shall be in full force and effect immediately upon its passage and approval.
