**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Section 17-3-0503-E of the Municipal Code of Chicago is hereby amended by deleting the language struck through, as follows:

**17-3-0503-E** *Pedestrian streets* also radiate from the following six-corner intersections.

**SECTION 2.** The Chicago Zoning Ordinance is hereby be amended by removing the Pedestrian Street symbols and indications radiating out from the intersection of North Broadway, West Lawrence Avenue and North Racine on Maps No. 11-G and No. 13-G along the following street segments:

North Broadway between the centerline of West Ainslie Street and West Leland Avenue;

West Lawrence Avenue between the centerline of North Malden Avenue and the centerline of North Winthrop Avenue; and

North Racine Avenue between the centerline North Broadway and the centerline of West Leland Avenue

**SECTION 3.** This ordinance shall effect after its passage and publication.
