ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 9-J in the area bounded by

The alley next south of and parallel to West Irving Park Road; the alley next east of and parallel to North Christiana Avenue; a line 33.33 feet south of and parallel to the alley next south of and parallel to West Irving Park Road; North Christiana Avenue

to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District.

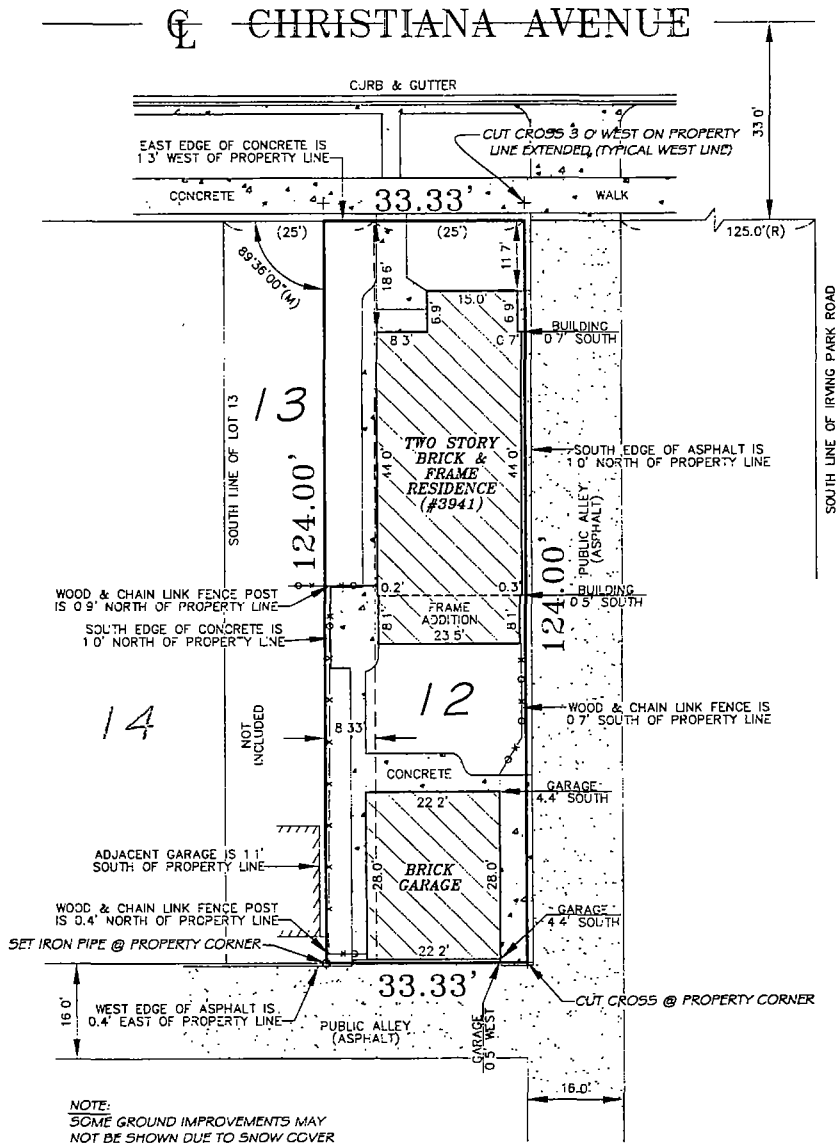
SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
