ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the M1-1 Limited Manufacturing/Business Park District symbols and indications as shown on Map No.9-I in the area bounded by

West Irving Park Road; a line 276 feet west of and parallel to North Western Avenue; the alley next south of and parallel to West Irving Park Road; and a line 326 feet west of and parallel to North Western Avenue,

to those of a B3-5 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

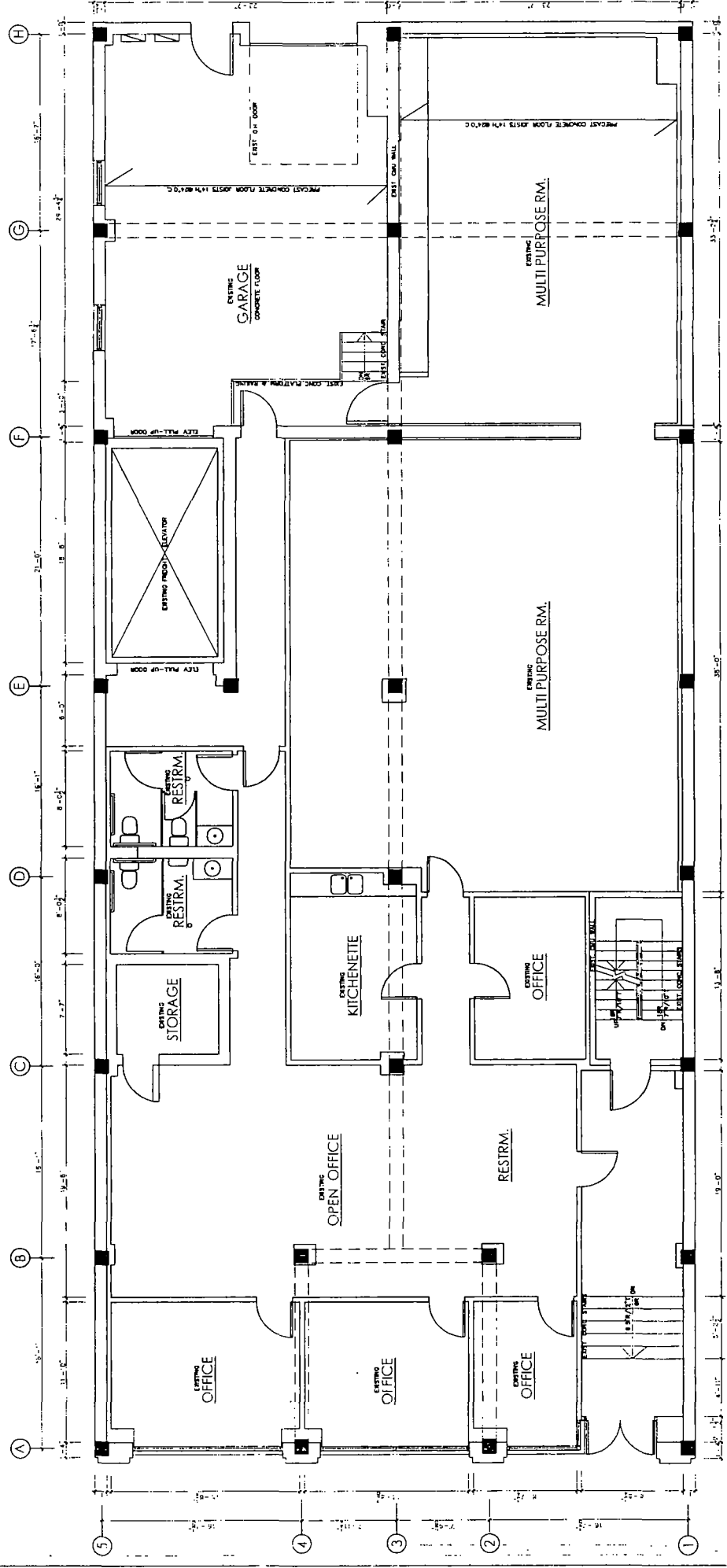


EXISTING BASEMENT PLAN

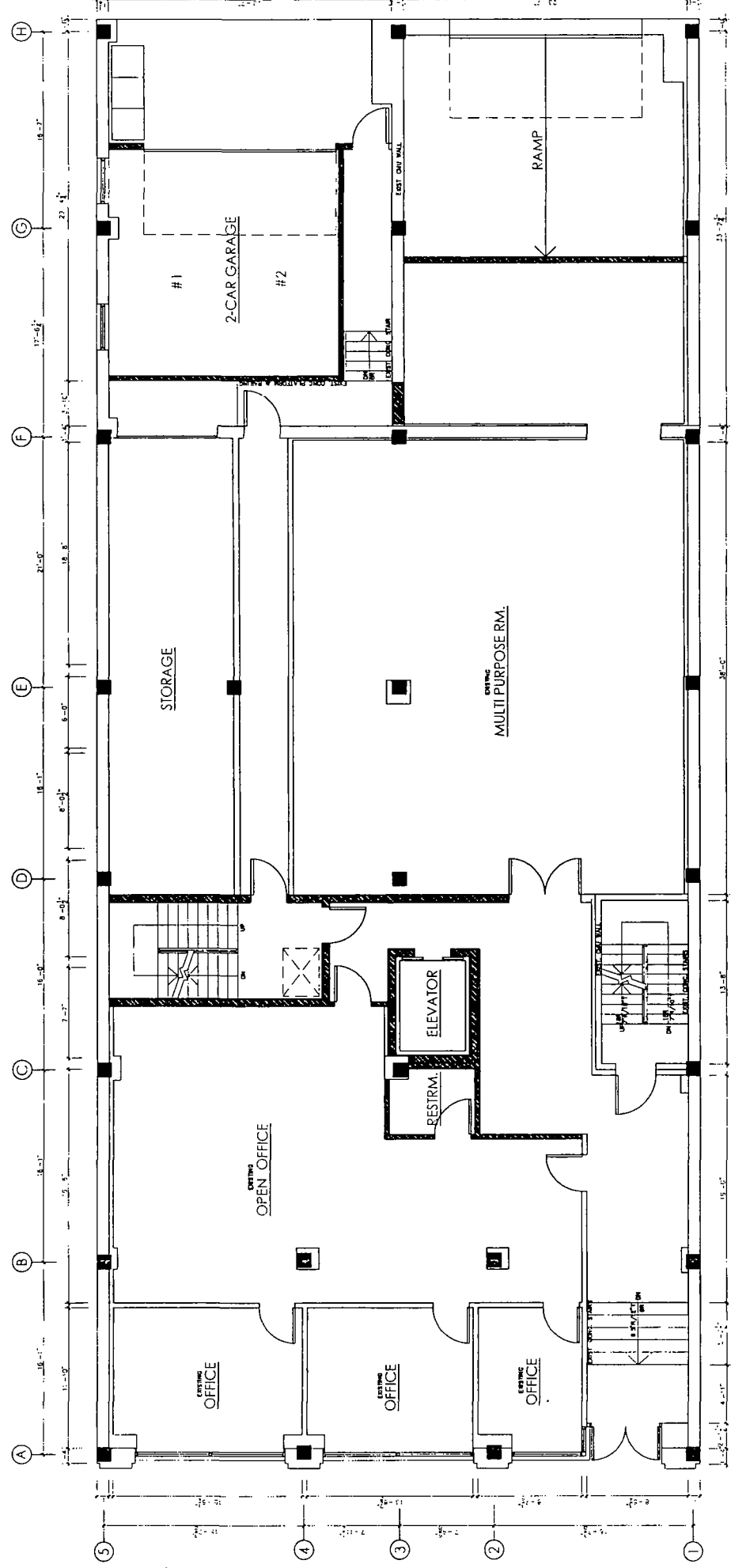


BASEMENT FLOOR PLAN

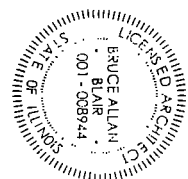


ROOF PLAN
