**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the underscored language and deleting the language struck through, as follows:

**4-60-022      Restrictions on additional licenses.**

Subject to the provisions of subsection 4-60-021(c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

*(Omitted text is unaffected by this ordinance)*

(19.23) On the west side of Western Avenue, from 117th Street to 119th Street.

(19.24) On the north side of 115th Street, from Kedzie Avenue to Spaulding Avenue.

*(Omitted text is unaffected by this ordinance)*

**SECTION 2.** Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language and deleting the language struck through, as follows:

**4-60-023      Restrictions on additional package goods licenses.**

Subject to the provisions of subsection 4-60-021(c), no additional package goods license shall be issued for any premises located within the following areas:

*(Omitted text is unaffected by this ordinance)*

(19.23) On the north side of 115th Street, from Kedzie Avenue to Spaulding Avenue.

(19.24) On the west side of Western Avenue, from 99th Street to 101st Street.

(19.25) On the west side of Western Avenue, from 101st Street to 103rd Street.

(19.26) On the west side of Western Avenue, from 103rd Street to 105th Street.

(19.27) On the west side of Western Avenue, from 105th Street to 107th Street.

(19.28) On the west side of Western Avenue, from 107th Street to 109th Street.

(19.29) On the west side of Western Avenue, from 109th Street to 111th Street.

(19.30) On the west side of Western Avenue, from 111th Street to 113th Street.


(19.31) On the west side of Western Avenue, from 113th Street to 115th Street.

(19.32) On the west side of Western Avenue, from 115th Street to 117th Street.

(19.33) On the west side of Western Avenue, from 117th Street to 119th Street.

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage and publication.


