BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-1 Limited Manufacturing/Business Park District symbols and indications as shown on Map No 7-N in an area bounded by:

West Belmont Avenue; North Normandy Avenue; the public alley next south of and parallel to West Belmont Avenue; and North Rutherford Court

to those of a B3-1 Community Shopping District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.





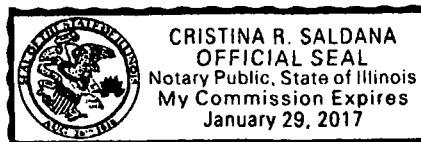

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about June 5, 2013, this firm will file an application for a change in zoning from a M1-1 Limited Manufacturing/Business Park District to a B3-1 Community Shopping District on behalf of 6701 W Belmont LLC, for the property located at **6701 West Belmont Avenue**.
