## ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-1 Neighborhood Commercial District symbols and indications as shown on Map No. 1-G in the area bounded by the alley next south of and parallel to West Fulton Street; North May Street; the alley next north of and parallel to West Lake Street; the alley next west of and parallel to North May Street to those of a C1-3 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.

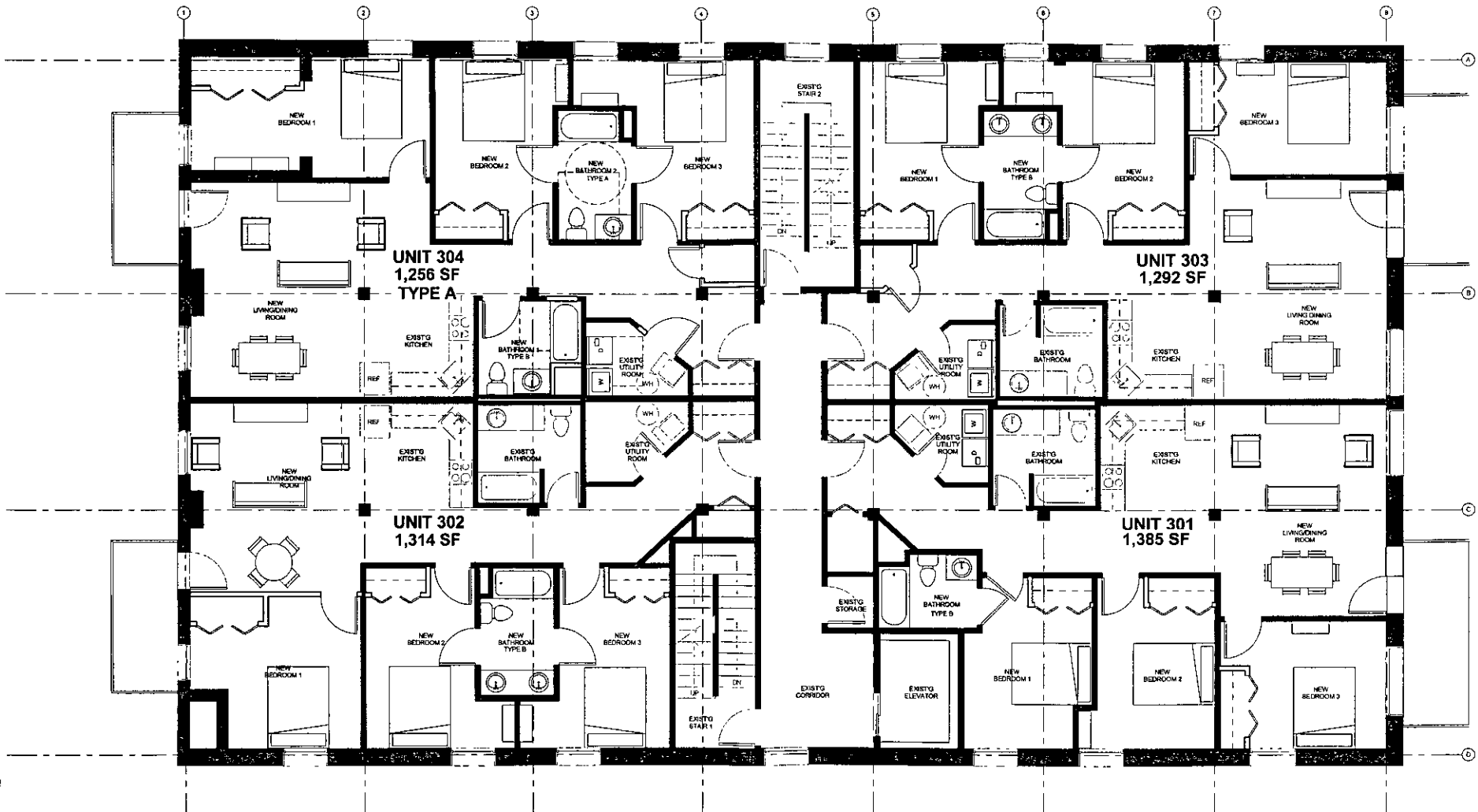

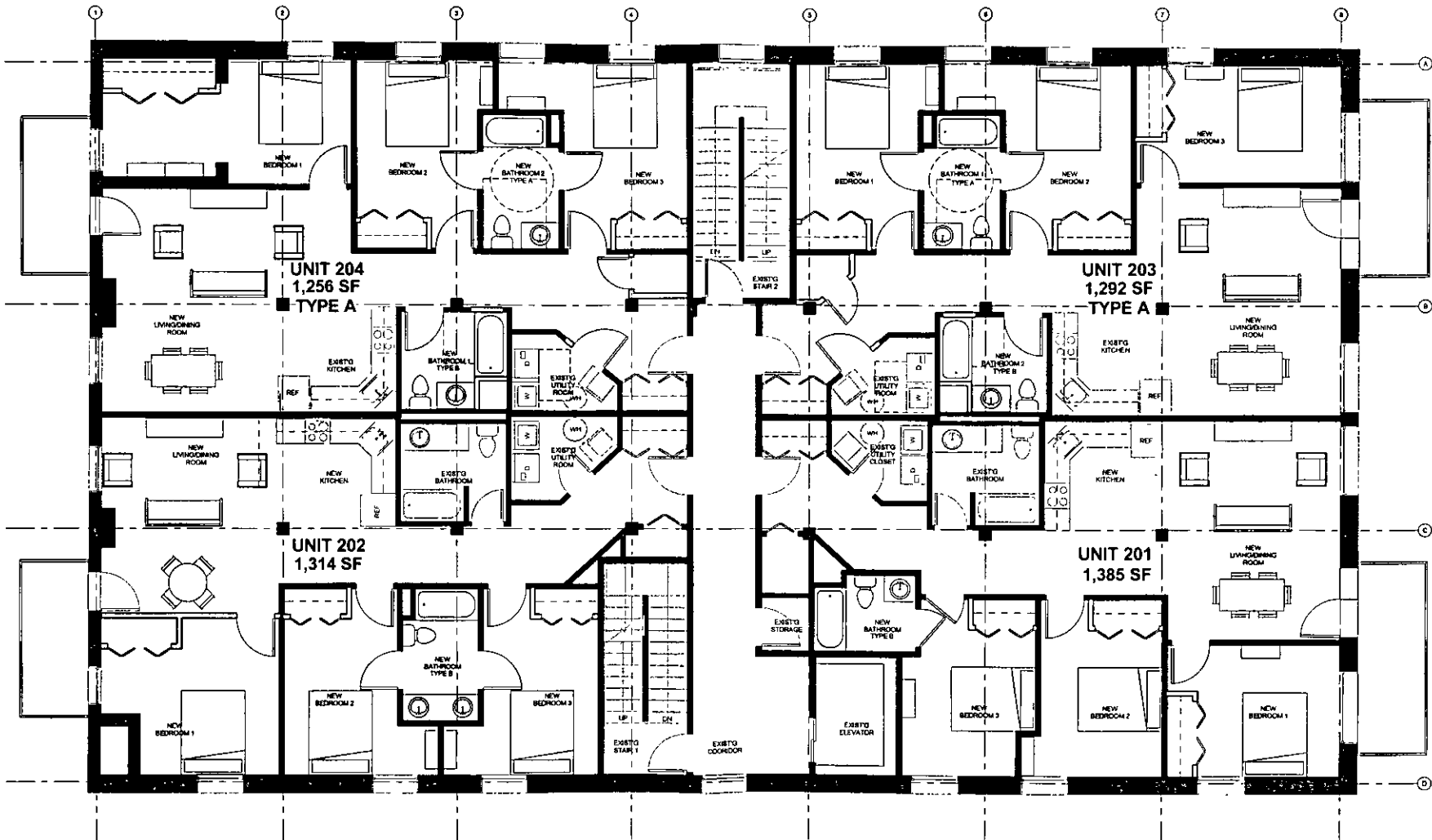
### FOURTH FLOOR PLAN



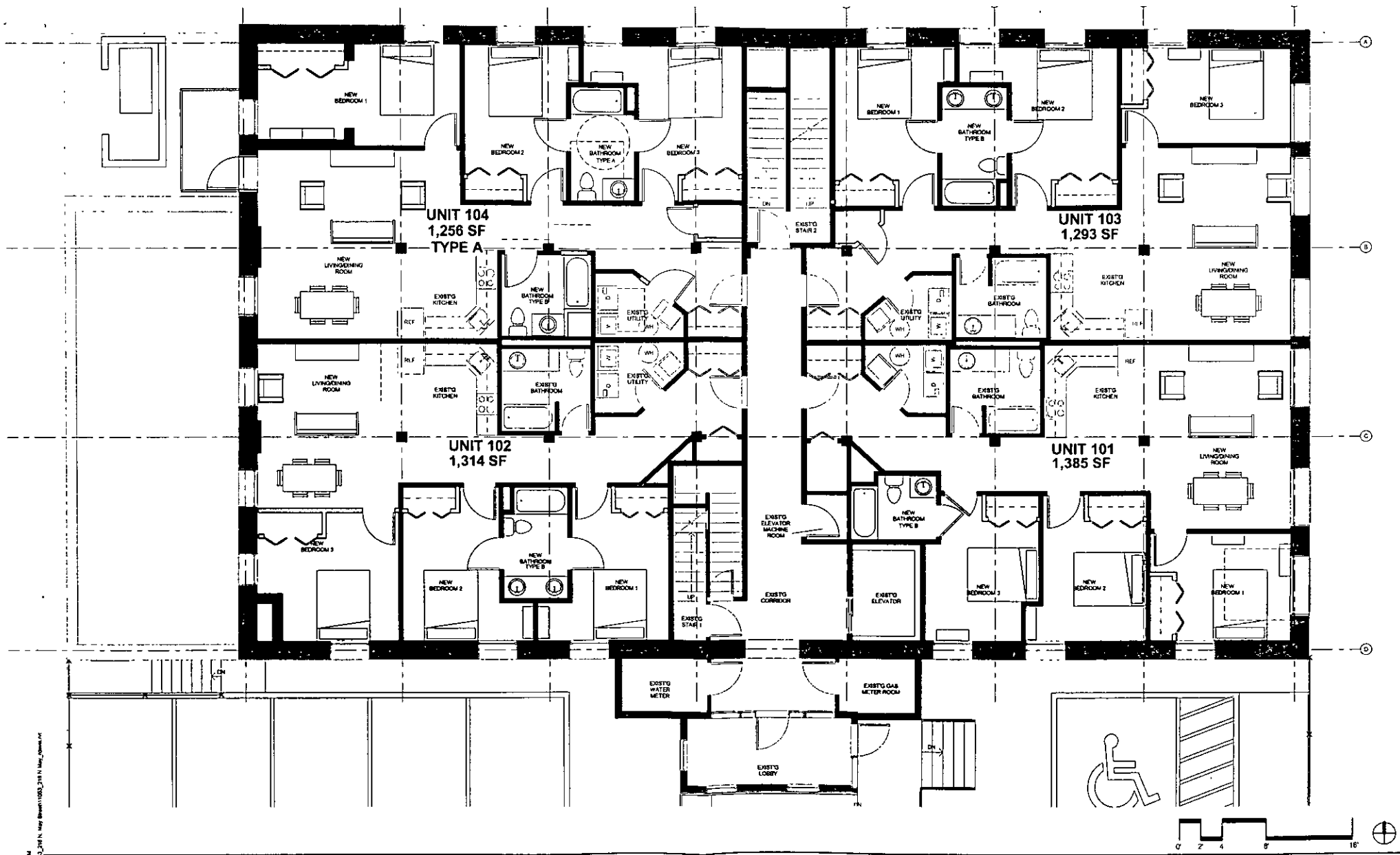

THIRD FLOOR PLAN

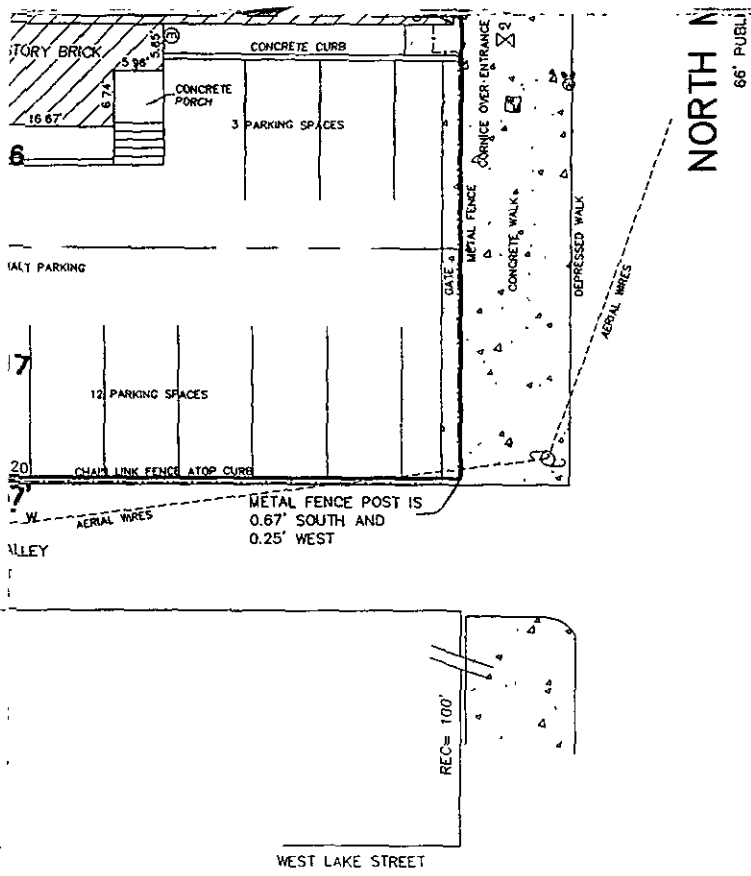


**SECOND FLOOR PLAN**

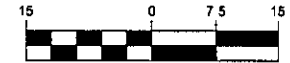

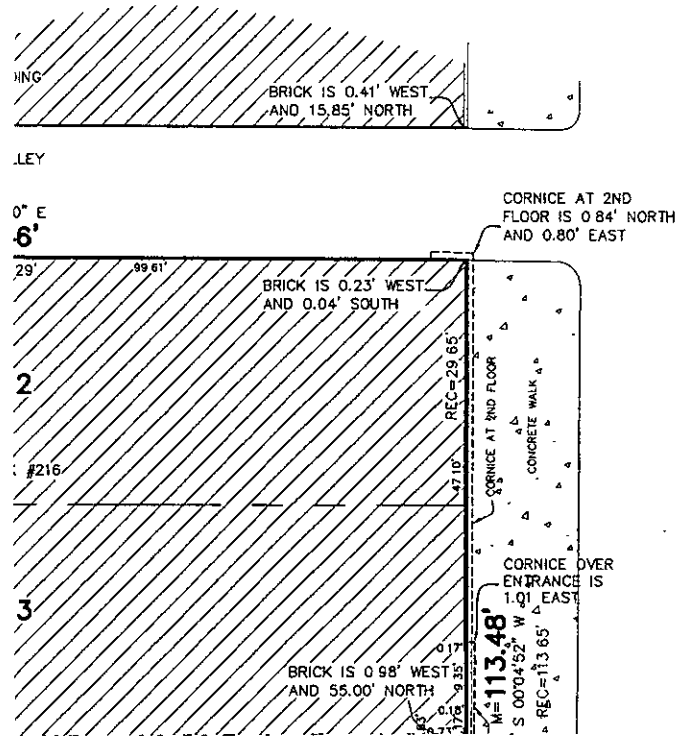
