THE FORDHAM CONDOMINIUM

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to THE FORDHAM CONDOMINIUM, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Manhole(s) under the public right-of-way adjacent to its premises known as 25 E. Superior St..

Said Manhole(s) at E. SUPERIOR ST. measure(s):

Two (2) at four (4) feet in length, and four (4) feet in width for a total of thirty-two (32) square feet.

Said Manhole(s) at N. WABASH AVE. measure(s):

One (1) at four (4) feet in length, and four (4) feet in width for a total of sixteen (16) square feet.

Said Manhole(s) at E. HURON ST. measure(s):

One (1) at four (4) feet in length, and four (4) feet in width for a total of sixteen (16) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1119936 herein granted the sum of one thousand six hundred (\$1,600.00) per annum in advance.

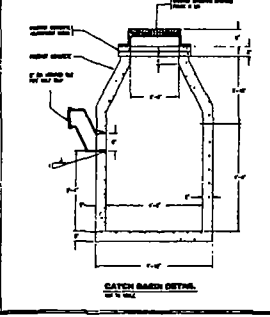
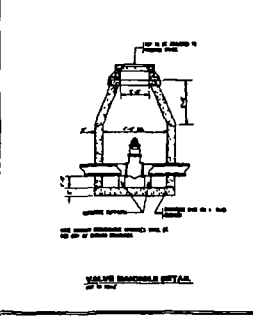
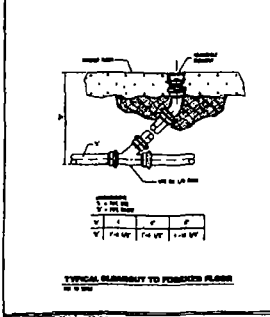
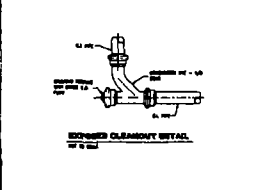
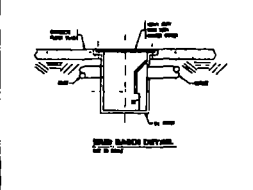
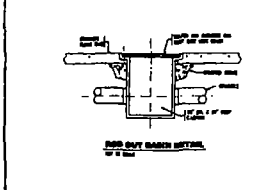
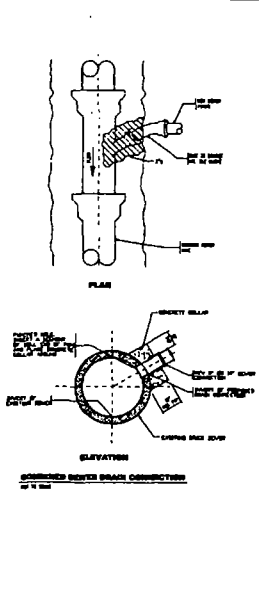
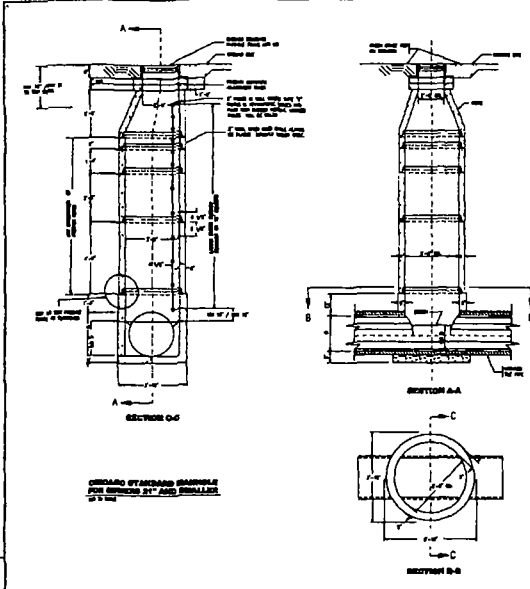
A 25% penalty will be added for payments received after due date.
