EAST ELEVATION

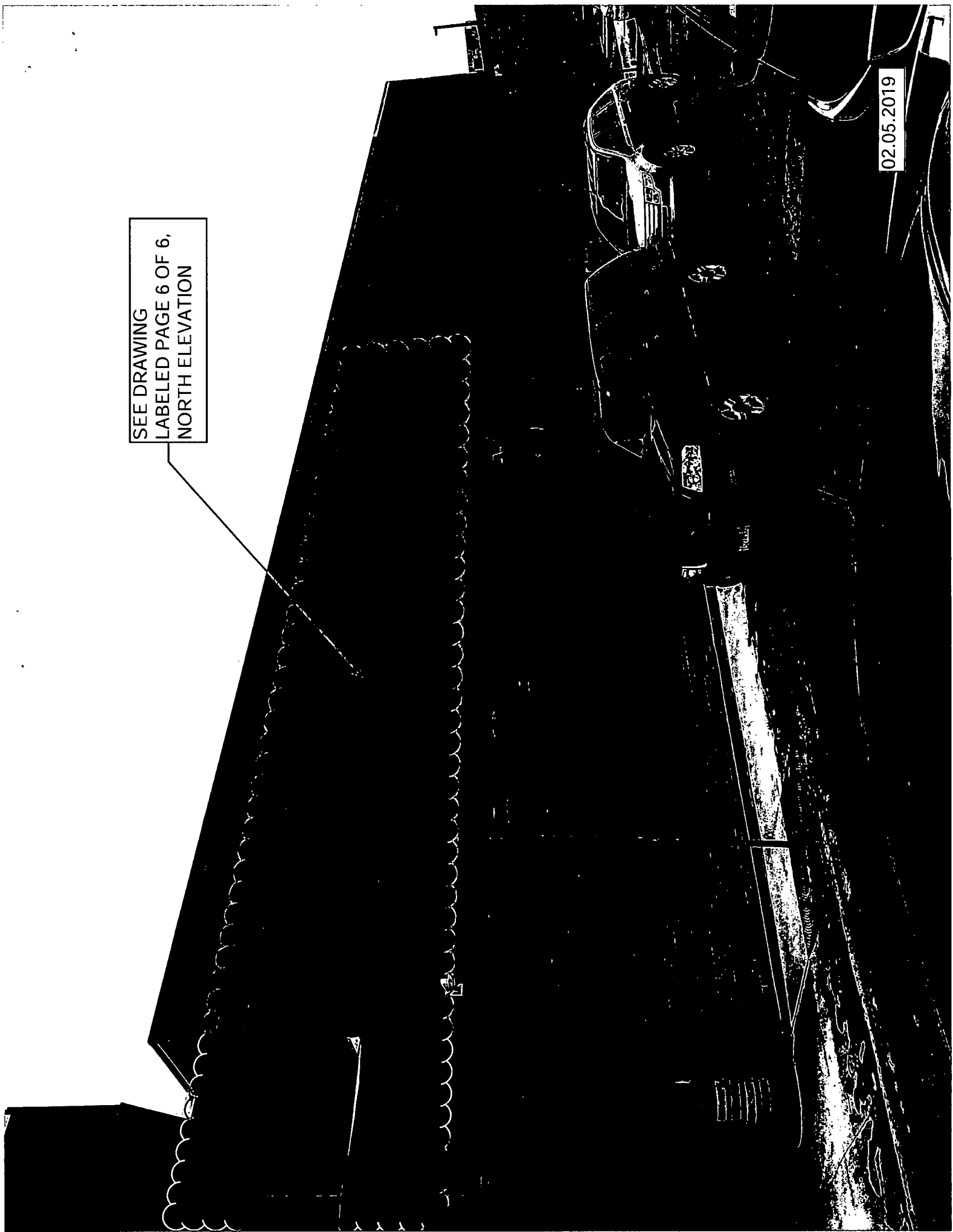

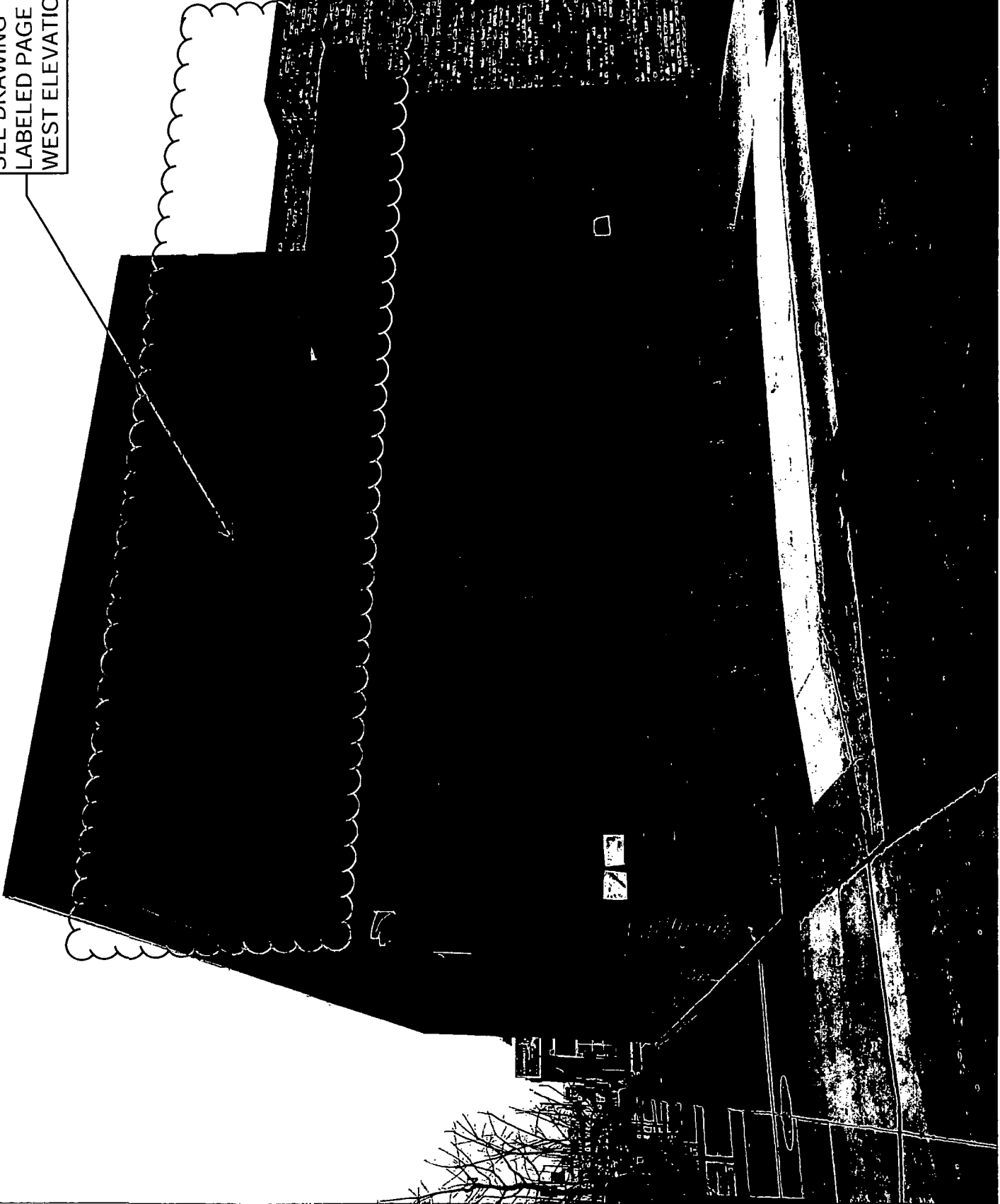
