ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-1, Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 22-G in an area bound by

The public alley next north of and parallel to West 94<sup>th</sup> Street; a line 200 feet west of and parallel to South Sangamon Street; West 94<sup>th</sup> Street; And a line from a point 413.9 feet west of South Sangamon Street on West 94<sup>th</sup> Street to a point 364 feet west of South Sangamon Street and 163.75 feet north of West 94<sup>th</sup> Street

to those of a M2-1, Light Industry District.

SECTION 2. This ordinance takes effect after its passage and due publication.
