Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to BRISTOL CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, eighteen (18) Caisson(s) under the public right-of-way adjacent to its premises known as 57 E. Delaware Pl.

Said Caisson(s) at E. Delaware measure(s):

Six (6) at one (1) foot in length, and one hundred eighteen point five (118.5) feet in width for a total of seven hundred eleven (711) square feet

Said Caisson(s) at N Rush measure(s):

Six (6) at one (1) foot in length, and ninety (90) feet in width for a total of five hundred forty (540) square feet.

Said Caisson(s) at N. Ernst Ct measure(s):

Six (6) at one (1) foot in length, and twenty-four point nine (24.9) feet in width for a total of one hundred forty-nine point four (149.4) square feet

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago

The grantee shall pay to the City of Chicago as compensation for the privilege #1130388 herein granted the sum of four hundred (\$400 00) per annum in advance


A 25% penalty will be added for payments received after due date

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way

Authority herein given and granted for a period of five (5) years from arts, after 11/05/2017.
