ORDINANCE

WHEREAS, the City of Chicago (the "City"), is a home rule unit of government under Article VII, Section 6(a) of the Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Board of Education of the City of Chicago (the "Board") is a body corporate and politic, organized under and existing pursuant to Article 34 of the School Code of the State of Illinois, 105 ILCS 5/1-1, et seq. (the "School Code"); and

WHEREAS, the Board is the owner of real estate located at 511 South Plymouth Court, Chicago, Illinois, which is improved with an approximately 5,202 square foot parking lot and legally described on Exhibit A, attached hereto ("Property"); and

WHEREAS, title to the Property is currently held by the City, as Trustee, in Trust for the Use of Schools; and

WHEREAS, the Board advertised the Property for sale from April 25 to October 24, 2014 pursuant to public notices that appeared in the Chicago Tribune on three (3) occasions, and received three (3) bids for the Property, which bids were opened in the Board's Department of Procurement and Contracts on October 24, 2014, the closing bid date; and

WHEREAS, one appraisal was made for the Property indicating the value of the Property as follows:

Appraiser: KMD Valuation Group, LLC

As of: December 8, 2014

Value: \$620,000 to \$690,000; and

WHEREAS, pursuant to Resolution Number 15-0128-OP3 (the "Resolution"), adopted by the Board by a vote of not less than two-thirds of its full membership at its meeting on January 28, 2015, the Board recommended the acceptance of the bid from Park One, Inc. d/b/a Dearborn Parking Corp., located at 54 E. Harrison Street, Chicago, Illinois ("Park One"), in the amount of Six Hundred Thirty-Five Thousand and No/100 Dollars (\$635,000), which bid was the highest bid received; and

WHEREAS, the Resolution includes a request that the City convey the Property to Park One, in accordance with the Resolution; and

WHEREAS, the Resolution states, in part, that the Board has determined that the Property has become unnecessary for school purposes, and that the sale of the Property is in the best interests of the Board, in accordance with Section 5/34-21 of the School Code; now, therefore,

Be It Ordained by the City Council of the City of Chicago:

Section 1. The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a deed conveying to Park One all rights of the City in Trust for the Use of Schools in and to said Property.

Section 2. Pursuant to the Board's request and the terms of the bid, the deed shall be subject to a restrictive covenant that the Property may not be used for kindergarten through high
