**SUBSTITUTE ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** The City Council finds that the areas described in Section 2 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell package goods within and near the areas.

**SECTION 2.** Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (49.22), which was previously deleted as shown in the Journal of Proceedings of September 11, 2013 at page 59822, with the following underscored text:

4-60-023 (49.22)      On Sheridan Road from Lunt Avenue to Pratt Boulevard.

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage and publication.
