WHEREAS, Donald F. Flynn was a widely admired member of the business community and the loving husband of Beverly; and

WHEREAS, Donald F. Flynn was the much-adored father of Kevin and Brian and the grandfather of five to whom he imparted many of the fine and noble qualities which he possessed in abundance; and

WHEREAS, Proud of his South Side roots, Donald F. Flynn was a devoted alumnus and supporter of Chicago's Leo High School, a Catholic secondary school which today serves young men who reside primarily in the inner city; and

WHEREAS, Donald F. Flynn inspired the lives of countless people through his great personal goodness, charity and concern; and

WHEREAS, The hard work, dedication and sacrifice of Donald F. Flynn serve as an example to all; and

WHEREAS, His love of life and ability to live it to the fullest endeared Donald F. Flynn to his family members, friends and all who knew him, and enabled him to enrich their lives in ways they will never forget; and

WHEREAS, Donald F. Flynn will be dearly missed and fondly remembered by his many relatives, friends, and colleagues; and

WHEREAS, To his beloved family, Donald F. Flynn imparts a legacy of faithfulness, service and dignity; now, therefore
